### 1. CALL TO ORDER

Ms. Johnson shared the images submitted by the seven short-listed artists as recommended by the jury. Commissioner Nelson moved to approve the recommendation, seconded by Commissioner Murray. During discussion, Commissioners determined that the work of the jury was incomplete until the list had been trimmed to six semi-finalists. Commissioner Nelson withdrew her motion. Commissioners narrowed the list to six and assigned 2 artists to design artwork for each of the three honored musicians:

**Bert Wilson:** Michele A. Burton and Arrington de Dionyso

**Verne Eke:** Jennifer Kuhns and Yelizaveta Bakhtina

Commissioner Grisham moved to modify the jury's recommendation from seven shortlisted artists to six, as determined by the Arts Commission. Vice-chair Jennings seconded. The motion was passed.
