1. CALL TO ORDER

1.3 City Gateways - Ms. Johnson said the presentation to the Planning Commission, the same as was presented to the Arts Commission in July, was well-received, and the draft concepts had their full support. Commissioners reviewed a followup document from Lesley Bain at Framework. Based on the conversation that followed the document review, Commissioners agreed to the title "Crossings" for the project, which references the fabric theme presented by the consultants, as well as the physical nature of the project and connection between neighborhoods and downtown. Commissioners agreed the project should incorporate paired elements that will visually identify this project among others.

2.2 Public Art Assessment - Work continues on annual maintenance, as the Park Seasonal works his way through the collection. Ms. Johnson reported "Dignity in Labor" was removed from its pedestal due to vandalism, and will be repaired and replaced.

2.4 Traffic Box Mural Wrap Public Art Project - Ms. Johnson shared she heard from Puget Sound Energy that they were developing a policy that would allow for the possibility to wrap their utility boxes. The details are unknown but the policy should be out in the fall.
