Commissioners reviewed the 2026 Arts Commission Work Plan and Municipal Art Plan. Staff had proposed increases to the Arts Walk cover commission, Artist in Residence Program, and reimbursable supplies for the Poet Laureate program. To this, Commissioner Garey proposed an increase of \$200 to each of the 4 Poet Laureate payments, as the stipend had not increased in a number of years. Commissioners agreed. Commissioners also commented on the range of arts programs, including low-barrier opportunities, and the ability for community members to see art where they are at.

Commissioner Burlingame moved to approve the 2026-2027 Work Plan and Municipal Art Plan as edited and approve for recommendation to City Council, seconded by Vice-Chair Ransom. The motion was approved.
