

City of Olympia Cultural Access Advisory Board Application

Advisory committees are a structured way for individual community members to share their opinions and perspectives, study issues, and develop recommendations in a focused small group. Their primary purpose is to provide judicious advice, from a community member's perspective, to the Olympia City Council.

The Olympia Cultural Access Program Advisory Board was established to ensure that that the Cultural Access Program provides public benefits. The Board advises the City Council on the formulation of processes, procedures and criteria for carrying out the goals of the Cultural Access Program and ensures that the program's expenditures are invested based on the priorities and commitments made to Olympia voters.

The City of Olympia values participation from all perspectives and life experiences and looks for equity and inclusion in advisory committee appointments.

To reduce barriers to community member participation the City offers stipends of \$25 per meeting attended to advisory committee members. Those members who certify as low income are eligible to receive stipends of \$50 per meeting attended. Advisory Committee members may waive the stipend upon request.

The Olympia City Council's General Government Committee recommends appointments to the full Council. Recommendations are made following review of applications and interviews of qualified candidates.

I hope to help launch this important new effort in Olympia for the best possible results: providing equitable support for arts, science, and cultural organizations; strengthening the capacity and impact of these organizations; expanding access and participation across our community.

I envision that key start-up tasks will include establishing conflict of interest policies; outreach; building a shared vocabulary; setting expectations for documentation, evaluation, and evidence of public benefit; demonstrating fairness, equity and transparency.

I prefer to serve one or two years, not a full three-year term: Long enough to help launch, then move aside for others to step up.

I bring a unique combination of skills including extensive experience and perspectives in public sector arts administration as well as the views of an individual community member.

I consciously use my administrative experience to mentor colleagues and cultivate partnerships. I worked towards passage of the enabling legislation, advised and assisted with the Olympia campaign, and tracked similar efforts elsewhere.

- I am a founding board member of two Olympia nonprofit cultural organizations and continue to provide leadership for both: now as Board Secretary for Olympia Artspace Alliance and as Board Secretary for Olympia Arts + Heritage Alliance.
- At Madison Elementary, I am a "Reading Buddy" a weekly assignment to sit 1:1 with third graders and a book of their choice.
- I served on the hiring committee for Arbutus (2019-2020).
- I participate in the ODA's downtown clean-up days.
- I organized two presentations "Arts and Healthy Communities" (for OPOP and for the ODA) by Karen Bubb, public art manager for the City of Boise.
- I retain a great relationship with ArtsWA and my colleagues in the arts and in State government. My resume provides a broader list of various roles I have served in our community and elsewhere.

Describe your experience with and knowledge of the communities and organizations meant to be served by the Olympia's Cultural Access Program.

I have general knowledge of the cultural organizations, artists, and historians in our community but have more to learn. I regularly attend events, seek out news and updates, and work to be a positive influence on this sector of our community. In the past three years I have actively engaged in a variety of initiatives, projects, study groups and briefings on equity, diversity, justice and inclusion, including with Olympia Artspace Alliance, Olympia Arts + Heritage Alliance, the Community Foundation of South Puget Sound, Puget Sound Estuarium, the Squaxin Island Tribe and my book club.

List your educational and/or professional background and area of study.

I worked for more than 20 years in public sector arts administration: Executive Director of the Washington State Arts Commission (now known as ArtsWA) for more 15 years, and Executive Director of the Boise City Arts Commission for more than 5 years. Since moving to Olympia in 1999 I have been active in Olympia's arts scene, and a strong supporter of the City's commitment to the arts.

I have benefited from numerous professional development opportunities in public sector leadership, arts management, advocacy, grantmaking, creative placemaking, expanding diversity in/with/for cultural organizations, documenting public benefit and more.

At ArtsWA I was in on early efforts that led to the passage of RCW 36.160 authorizing Cultural Access programs.
