Washington State Liquor Control Board Adopts Amended Banned Product Lists for Olympia's Alcohol Impact Areas

On April 8, 2015, the WSLCB Board approved the city of Olympia's request to amend the banned products in the Downtown Alcohol Impact Areas effective immediately. All banned products must be removed from retail licensee premises by May 7, 2015.
