1. Description of Project & Goal(s):

The ODA Design Committee has worked in the past in improving a sense of safety in problematic areas of downtown by following the principles of crime prevention through environmental design. The year, the committee decided to continue our focus on a project to improve an alley frequently used by pedestrians and bicyclists. This will be our 6th project in the downtown core.

The alley we've selected is the one going from west to east starting from Jefferson Street. It is right across the street from the Artesian Well Park and is frequently used by pedestrians walking to City Hall, despite its unkempt look – graffiti and standing water are often problems. It is also the location of an artesian well that is currently just a pipe being diverted into the storm drain.

Using 2013 grant money among other resources, we commissioned a beautiful mural by noted artist Ira Coyne. This year, we are focused on artwork that is more three dimensional.

We will work with H2Oly to find an artist that will utilize or incorporate the Artesian well water as a part of the artwork, perhaps a Kinetic sculpture like in Turtle Place in Vancouver or an archway or sculpture that uses the water movement to make a musical sound. We are leaving the concept somewhat opened ended, as we wish to see what artists may come up with on their own. However, they will be given strict guidelines such as the water from this well will NOT considered as potable, but as an extension of the current park and a way to continue to highlight the unique history of Olympia's artesian wells. Also, the artist must take into account that the neighboring building owners and businesses concerns about potential harm to their buildings (including, but not limited to, it being used as a ladder).

We are also in communications with Public Works in how to deal with the standing water issues. There are plans to resurface the alley to correct issues such as standing water this summer. Our plans are to have the artist build and create the artwork "off site" – and we will work in collaboration with Public Works and Community Planning and Development on the installation, as well as seek advice from Stephanie Johnson of the City of Olympia Arts Commission regarding our process. Ms. Johnson has been a big help in advising the Design Committee in our program in the past.

This project is part of an ongoing campaign by the Design and Safety Committees to make downtown both cleaner and safer through the principles of Crime Prevention through Environmental Design.

The improvement of any of the three alleys mentioned will help in the ongoing goal of making Olympia more pedestrian friendly. We feel this project dovetails nicely with the City of Olympia's Downtown Project.

Arrangements will be made with the artist to maintain or make any repairs as needed. Any and all work will be done with the input and cooperation of affected private property owners.
