## 6. PRESENTATIONS

16-1215 Action Plan Briefing

CP&D Deputy Director Leonard Bauer shared background and an overview of the Action Plan to date. The Action Plan is organized into five action areas - 3 topical and 2 geographic - with actions, strategies and outcomes available on the City website. Commissioners updated a few missing actions and directed staff to make workplans and the Municipal Art Plan available to CP&D early in the Action Plan annual cycle.

Commissioners also asked that Deputy Director Bauer be invited to return for a subsequent update during the Commission retreat next fall.

#### 7. BUSINESS ITEMS

16-1237 Selection of 2017 Officers

Commissioner Hinton nominated Vice-Chair Stacy Hicks for 2017 Arts Commission Chair, and Chair Marygrace Jennings for 2017 Vice-Chair. He invited comment from other Commissioners who responded with support for his nomination.

Chair Jennings moved, seconded by Commissioner Murray, to approve Vice-Chair Hicks for 2017 Chair. The motion passed.

Vice-Chair Hicks moved, seconded by Commissioner Fairbanks, to approve Chair Jennings for 2017 Vice-Chair. The motion passed.

16-1225 Approval of Poet Laureate for 2017-2019

Ms. Johnson shared the jury's recommendation of Amy Solomon-Minarchi as Poet Laureate and Cecily Markham as alternate for 2017-2019. She distributed copies of Ms. Solomon-Minarchi's application and shared video poetry readings by both poets. Vice-Chair Hicks provided the juror's persepective to Commissioners, shared there was a very qualified pool of applicants, and that the jurors felt very solid about their recommendation. Commissioners directed staff to invite Ms. Solomon-Minarchi to their December 8 meeting.

Chair Jennings moved, seconded by Vice-Chair Hicks, to forward the jury recommendation to City Council for approval. The motion passed unanimously.

<u>16-1219</u> Approval of Arts Walk date recommendation

Commissioners discussed the staff report that explored moving the spring 2017 Arts Walk date. They felt that Arts Walk has long been associated with the 4th Friday and Satruday in April, and that moving it would become a source of conflict with other events.

Chair Jennings moved, seconded by Commissioner Hinton, to keep Arts Walk at its current date of the 4th Friday and Saturday in April. The motion passed unanimously.
