A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OLYMPIA, WASHINGTON, RELATING TO THE APPOINTMENT OF PERSONS TO PREPARE VOTERS' PAMPHLET STATEMENTS FOR AND AGAINST THE CITIZENS' INITIATIVE BALLOT PROPOSITION TO ADOPT AN ORDINANCE TO ESTABLISH A WORKERS' BILL OF RIGHTS FOR LABOR STANDARDS CONCERNING WORK SCHEDULING, A MINIMUM WAGE IN THE CITY, A SAFE WORKPLACE ENVIRONMENT, AND OTHER LABOR REGULATIONS, SCHEDULED TO APPEAR BEFORE VOTERS AT THE NOVEMBER 4, 2025, GENERAL ELECTION

WHEREAS, the City Council of the City of Olympia, Washington (the "City") has determined that it is in the interest of the City and its residents to submit a citizens' initiative proposition to the voters at the General Election on November 4, 2025, concerning an ordinance to establish a workers' bill of rights for labor standards concerning work scheduling, a minimum wage in the City of Olympia, a safe workplace environment, and other labor regulations; and

WHEREAS, RCW 29A.32.280 provides for the preparation of statements for and against each local ballot measure by committees of not more than three persons each, comprised of persons known to favor or oppose the ballot proposition;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OLYMPIA, WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:
