SIGNIFICANCE OF PROJECT OR PERSON:

In the last several years the Wildwood Center has become a thriving commercial enterprise and center of community activity on Capitol Blvd. Folks from the neighborhoods walk, bike and bus to shop, eat, drink coffee and visit with friends. As a Wildwood neighbor told me "people are coming and going all day long!"

The Shattuck family is nominated for preserving this distinctive Art Moderne style mid-century commercial building and keeping it largely intact. Built in 1943 and designed by Joseph Wohleb for G. Valley, the building was originally the G. Valley Shopping Center an early interpretation of the shopping center idea (see DAHP Historic Property Inventory Report.) In the 1990s the Shattuck family purchased the building, then in disrepair and have been thoughtful stewards of the historic structure repairing and upgrading it.

The four tenants are nominated for reinvigorating the historic space and turning it into a thriving commercial center for the Wildwood, Governor Stevens and Carlyon historic neighborhoods. It isn't enough to preserve a building as an historic relic. To sustain its place in the future of the city, it must be a vital part of the larger community. These tenants saw the potential and synergy in locating in an historic building in a neighborhood with pedestrian and transit activity. And in doing so they help to secure the future of this one of a kind mid-century building.
