BUSINESS

Discussion and Preparation of List of Recommendations for 2012 Funding

A list of combined rankings was distributed and discussed. There were 28 proposals considered for funding totaling \$607,500. The contributions from the participating jurisdictions are anticipated as follows:

City of Tumwater \$25,000 Thurston County \$75,000 City of Lacey \$45,000 City of Olympia \$76,000

Total of \$221,000 Available

General discussion of the overall need and the quality of the applications was held by all members present. Members were concerned that the need far exceeded the available funding. Jeff Gadman suggested funding all agencies at 80% of the requested amount in order to fund beyond the current rankings and requested amount.

There was discussion regarding funding at a lesser amount in order to be able to fund additional proposal(s).

Cathy Wolfe suggested funding at 75% of their requested amount.

After further discussion, Cathy Wolfe moved to fund at 75% as far down the list as funding is available and fund the next highest ranked proposal with the remaining balance. Betsy Spath seconded the motion. The motion carried.
