# 6. BUSINESS ITEMS

# **6.A** <u>15-0107</u> Olympia Heritage Commission (OHC) Evaluation of National Register Nomination of the Trueman & Virginia Schmidt House

Ms. Sadlier presented the criteria for evaluation by the National Register of Historic Places in preparation for discussion regarding the nomination form review by the OHC for the Trueman & Virginia Schmidt House at 2932 Maringo Road SE.

#### Discussion:

- Importance of architect G. Stacey Bennett's contribution to Olympia architecture.

Ms. Danner, the owner of the Trueman & Virginia Schmidt House, discussed the history of the house, pointing to documents and drawings included with the evaluation, and shared detailed information about interior, exterior, and landscaping features of the home.

Commissioner Miller moved, seconded by Commissioner Harkness, to recommend the property be listed on the National Register of Historic Places. The motion passed unanimously.

**6.B** <u>15-0109</u> Preparation for OHC Retreat: Review of Approved 2014 Work Program

Ms. Sadlier discussed the upcoming retreat. The two main topics for discussion are the proposed 2015 Work Plan and Olympia Downtown Historic District. Ms. Sadlier proposed a focus on district boundaries and distinctions between contributing and noncontributing properties in the historic district.

#### Discussion:

- The intention for new development to be compatible with the feeling and historic aspects of Downtown.
- Past problems when remediation was inconsistent with historic criteria.
- Misperceptions about appropriate design "fitting in" with historic elements.
- Community Renewal Area criteria setting.

Commissioners reviewed the approved 2014 Work Plan and determined which work items to carry forward and/or add to the proposed work plan for the coming year.

The discussion was completed.
