

RESOLUTION NO. M-2640

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OLYMPIA, WASHINGTON, APPROVING A LOCAL AGENCY FEDERAL AID PROJECT PROSPECTUS AND LOCAL AGENCY AGREEMENT BETWEEN THE CITY OF OLYMPIA AND THE WASHINGTON STATE DEPARTMENT OF TRANSPORTATION FOR FEDERAL HIGHWAY ADMINISTRATION HIGHWAY SAFETY IMPROVEMENT PROGRAM GRANT FUNDS FOR THE MARTIN WAY PEDESTRIAN SAFETY IMPROVEMENTS PROJECT

WHEREAS, the City of Olympia applied for and received Federal Highway Administration (FHWA) Highway Safety Improvement Program (HSIP) City Safety Program grant funds (the Grant Funds) in January 2024 for the City's Olympia Martin Way Pedestrian Safety Improvements Project (the Project); and

WHEREAS, the current total estimated project cost is \$1,637,000. The cost estimate may change as staff and a consultant complete the design; and

WHEREAS, the City must sign and submit to the Washington State Department of Transportation a Local Agency Federal Aid Project Prospectus and Local Agency Agreement for the Grant Funds; and

WHEREAS, per Olympia Municipal Code Section 3.16.020(C), it is necessary for the City Council to approve the Local Agency Federal Aid Project Prospectus and the Local Agency Agreement and authorize the signature for all documents necessary to obligate funds for the Project;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL DOES HEREBY RESOLVE as follows:

1. The Olympia City Council hereby approves the Local Agency Federal Aid Project Prospectus, Local Agency Agreement, and subsequent Local Agency Agreement Supplement for construction funds between the City of Olympia and the Washington State Department of Transportation for Federal Highways Administration Highway Safety Improvement Program grant funds for the Martin Way Pedestrian Safety Improvements Project and the terms and conditions contained therein.
2. The City Manager is directed and authorized to execute on behalf of the City of Olympia the Local Agency Federal Aid Project Prospectus, Local Agency Agreement, Local Agency Agreement Supplement for construction funds, and any other documents necessary to obligate funds and complete the work for the Martin Way Pedestrian Safety Improvements Project, and to make any modifications as may be required and are consistent with the intent of the Prospectus and Local Agency Agreement, or to correct any scrivener's errors.
