1.2 Traffic Box Wrap - Ms. Johnson shared that with the recent departure of staff liaison Brian Wilson from the PBIA board, the decision has been made to not pursue extra wraps downtown. The project will now move forward into fabrication.

1.3 Music Out Loud - During the early part of the meeting, Ms. Johnson gave a brief presentation to PBIA members at the meeting next door about Music Out Loud. The response was positive, and PBIA members asked that they are consulted during the performance development of the project. The group concurred that noon

performances would be preferred as 11am-1pm are the busiest times downtown. 1.4 Percival Plinth Project - Commissioner Fairbanks recapped the People's Choice presentation to Council. She noted that Councilmember Langer expressed concern about placing Olympia Oyster in front of City Hall, and suggested an interior location.
