## II. ORDER

THIS MATTER having come before this Court upon the stipulation of the parties above contained, and the Court being fully advised in the premises, now, therefore, it is hereby

ORDERED, ADJUDGED AND DECREED that the below described dedicated alley/street area has been previously vacated by operation of law, pursuant to laws of 1889, 1890, Section 32, Chapter 19 which provides as follows:

Any county road, or part thereof, which has heretofore been, or may hereafter be authorized, which remains unopened for public use for the space of five years after the order is made or authority granted for opening the same, shall be, and the same is hereby vacated, and the authority for building the same barred by the lapse of time.
