Background and Analysis:

The City of Olympia's Fire Department has a fleet of 47 light (passenger-type) and heavy-duty (pumper and ladder trucks) vehicles. The current replacement value is approximately \$21 million. Of that, \$19 million represents the Department's heavy fleet. Based on industry-standard lifecycle schedules, staff estimates a financial need of about \$8.2 million over the next 10 years to replace fire vehicles and equipment. Historically, the City has replaced this equipment by issuing debt.

The City maintains a Fire Equipment Reserve Fund (Fire Reserve) with annual transfers from the General Fund. The annual contribution to the Fire Reserve is \$200,000 annually. It has been used to replace light-duty vehicles and to support some debt service payments on heavy equipment.

The City also maintains another Reserve Equipment Rental Fund (Reserve) to collect monies to be used for future replacement of vehicles and other rolling stock equipment for every City Department

with the exception of Fire. The Reserve is funded through a monthly lease rate per vehicle.

Staff will provide an overview of Fire's fleet replacement schedule, including the need for debt issuance to cover near-term replacement needs along with options to address a long-term funding strategy.

Background and Analysis:

At its February meeting the Finance Committee discussed wage impacts and other cost factors related to business and nonprofit organizations in the City. It also discussed the plight of low wage workers, the many factors that make it difficult to afford rising costs in Olympia along with increasing

operating costs facing locally-owned businesses and nonprofits.

The Committee concluded that increasing the City's understanding of local businesses and nonprofits serves a multitude of purposes. Olympia lacks data and needs a better understanding on employer size, employees, revenues, profitability, competitive environment, and current impacts and factors that affect the vitality of the local economy.

The Committee agreed that a first step, before any policy initiatives are developed, is to increase the City's understanding of these aspects of businesses and nonprofits so that any policy initiatives, such as minimum wage, can be better assessed to avoid unintended impacts. The City has some information about employers, wages, gross revenues and more through various sources such as B&O tax collection, business licensing information, and census data. However some of the information is not fully complete due to being aggregated with County level information or may contain other various data gaps.

Staff will brief the Committee on the available data, areas we need to develop, and a proposal for how to collect and analyze the data.

A strong and vital local economy is important to supporting fair and livable wages for all Olympians. The economic system that includes these elements is complex and affects nearly everyone in the community

Background and Analysis:

Thurston County is proposing to locate a new County Courthouse on the existing site of the Lee Creighton Justice Center on Plum Street in Olympia. The County's intent is to partner with the City to co-locate facilities. The City facilities at Plum street are old, inefficient and in need of significant upgrades and major maintenance. Partnering with the County presents the City an alternative to address these unfunded capital deficiencies. The preliminary planning level estimate for the City's portion is between \$25 - \$30 million.

On February 20, 2019, staff shared with Finance Committee a draft of future City capital projects and

equipment that may require debt funding over the next 10 years. Staff also shared a summary of our current outstanding debt. Finance Committee requested on-going evaluation and analysis to help inform them as they continue to explore the opportunity to participate in a joint facility with Thurston County.
