Q3. What would you change, remove or add?

Responses Summary (21 responses, 73 skipped)

11 out of 21 responses were related to grammar, punctuation or sentence structure. The other 10 comments were about adding or emphasizing specific values, activity or focus areas. There wasn't any trends or themes that showed up.

"A healthy, fun and enriching place to live for all Olympians."

Q5. What would you change, remove or add?

Responses Summary (30 responses, 64 skipped)

Themes in responses were around adding safety (5), diversity/inclusive/accessible (9), and climate/nature/trees (5) language to the "vision for the future."

Q6. Draft introduction paragraph

"Olympia's great parks, vibrant arts community, and many recreation and activity programs enrich our lives and strengthen our connection to the community. City of Olympia Parks, Arts & Recreation stewards 53 parks, which serve as community gathering places, contribute to a neighborhood's character and sense of place, and make positive impacts on our environment. We offer hundreds of recreation classes, camps, and programs each year, which build community, improve individual health and support the local economy. We make investments in public art that contribute to a creative, vibrant community, with Olympia's bi-annual Arts Walk events celebrating the arts as a defining characteristic of our community."

The draft introduction paragraph above was based on the recently adopted 2022 Parks, Arts and Recreation Plan. How do you feel about it?

Q7. What would you change, remove or add?

Responses Summary (31 responses, 63 skipped)

Many responses focused on the sentence structure, grammar and punctuation as having flaws. Some themes were – remove "Arts Walk" from the paragraph (too specific), add more about access and inclusive events/facilities and climate.

Q8. Public needs to feel safe and secure in parks and facilities

"While strategies enacted since the last plan have been effective in reducing the incidence of unsafe behavior in parks, facilities and services, there is still work to do to create a welcoming environment where all visitors feel safe and that they belong."

Q9. What would you change, remove or add?

Responses Summary (26 responses, 68 skipped)

Majority of responses were not satisfied with the statement due to vague, unrealistic or interpretation or use of specific words. A common topic in the responses was around houseless individuals and how this statement applies to their situation.

Q10. Public demand for new parks and arts exceeds resources

"Many of the most desired new park projects in Olympia will each cost tens of millions of dollars. These "mega projects" include Percival Landing reconstruction, completing the final two phases of the Karen Fraser Woodland Trail, developing West Bay Park and Trail, developing the Armory Creative Campus, and developing a community park at the Yelm Highway park site."

Q11. What would you change, remove or add?

Responses Summary (25 responses, 69 skipped)

Respondents want clarification on how/why these projects became a priority and why there isn't funding for them. Some concern around raising taxes. 5 comments around adding athletic/sports facilities. 3 were general, 2 were specific (Aquatic/pickleball).

Q12. Population growth creating demand for new park land

"Population is a key factor used to project needs for future parks, arts and recreation programs and facilities. As our population increases we will need more parks and open space to meet current service standards, yet less land and fewer large parcels are available."

Responses Summary (26 responses, 68 skipped)

There is a clear desire to have some solutions built into this challenge. Ideas around evolving or being innovative to address the needs. Inclusion of programs and facilities too.

Q14. Climate change impacts and action

"Climate change is impacting Olympia's parks and recreation activities. From sea level rise to frequent extreme weather events, we must mitigate these impacts and build a climate resilient parks system that will serve generations to come."

Responses Summary (15 responses, 79 skipped)

Some thought this was too vague or might push people away. A few comments were around specific examples such as preserving forested areas and properly designed facilities.

Q16. The immediate need to undo institutional injustice in Parks, Arts and Recreation services

"Equity, inclusion and belonging needs to be centered in parks, arts and recreation. We recognize our equity journey will present challenges and we commit to the responsibility to face these challenges while building the capacity and accountability resources to embed equity, inclusion and belonging in our daily practices and decision making. We will continually analyze the political, economic, sociodemographic, technological, legal, and environmental challenges facing our work. This will require continually developing solutions and mitigating strategies for the challenges."

Responses Summary (30 responses, 64 skipped)

The comments were mostly focused on wanting clarity and specific language. Many people thought the statement was a collage of buzzwords and not sincere.

Common locations mentioned Karen Fraser Woodland Trail, Percival Landing, Capitol Lake, Watershed and Yauger. Majority of concerns are around unhoused people, encampments and drug use.

Overall Summary:
