Description of Proposed Amendment: Reclassify 9<sup>th</sup> Avenue SW east of Boulevard Road from a local access street to a neighborhood collector street. Street classification will support area rezone to a higher land use density. Identify newly constructed existing streets to the street classification that they were designed to. Identify a future major collector street network that will support the Friendly Village area rezone from the previous RM-24 (residential mix-use) zoning to the current HDC-4 (high density commercial) zoning. This street network also provides connectivity to adjoining parcels, Cooper Point Road and Capital Mall Drive. Remove future neighborhood collectors between 20<sup>th</sup> and 28<sup>th</sup> Avenue NW that currently cannot be constructed with the presence of new development. Add and replace those future streets with new street connections to 20<sup>th</sup> and 28<sup>th</sup> Avenue NW.

Identify a future major collector street network that will support the Friendly Village area rezone from the previous RM-24 (residential mix-use) zoning to the current HDC-4 (high density commercial) zoning. This street network also provides connectivity to adjoining parcels, Cooper Point Road and Capital Mall Drive.

Remove future neighborhood collectors between 20<sup>th</sup> and 28<sup>th</sup> Avenue NW that currently cannot be constructed with the presence of new development. Add and replace those future streets with new street connections to 20<sup>th</sup> and 28<sup>th</sup> Avenue NW.

#### **1. How would the proposal be likely to increase discharge to water; emissions to air; production, storage, or release of toxic or hazardous substances; or production of noise?**

Future streets surfaces will increase water run-off into their respective watershed basins. New streets will supplement the existing Olympia street network. Street connections provide: shorter travel routes, decrease vehicle emissions, release of toxins and noise.

##### **Proposed measures to avoid or reduce such increases are:**

Connect to available sewer lines or develop water retention ponds.

#### **2. How would the proposal be likely to affect plants, animals, fish, or marine life?**

New street construction will remove all vegetation or animal habitat within the cross-section of the street. Stormwater run-off may increase toxins into streams and marine life habitat.

##### **Proposed measures to protect or conserve plants, animals, fish, or marine life are:**

Standard streets include 8 foot wide planter sections on both sides of the street. This area is used for street tree/shrubbery plantings. Street trees can offer habitat for animal life. Fish and marine life can be protected by connecting to available sewer lines or develop water retention ponds.

**3. How would the proposal be likely to deplete energy or natural resources?**

New street construction will remove all vegetation within the cross-section of the street.

**Proposed measures to protect or conserve energy and natural resources are:**

Standard streets include 8 foot wide planter strip sections on both sides of the street. This area is used for street tree/shrubbery plantings.

**4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?**

There is potential for new street connections to travel through or adjacent to environmentally sensitive areas.

**Proposed measures to protect such resources or to avoid or reduce impacts are:**

New street cross-section will be minimized to eliminate planter strip and parking when through or adjacent to an environmentally sensitive area. Fewer surfaces will reduce stormwater run-off and a narrower section will reduce the overall footprint of the street.

**5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?**

New street will support the existing zoning and land use regulations.

New streets will supplement the existing Olympia street and utility network. New street connections provide shorter travel routes and increase supply availability of utilities.

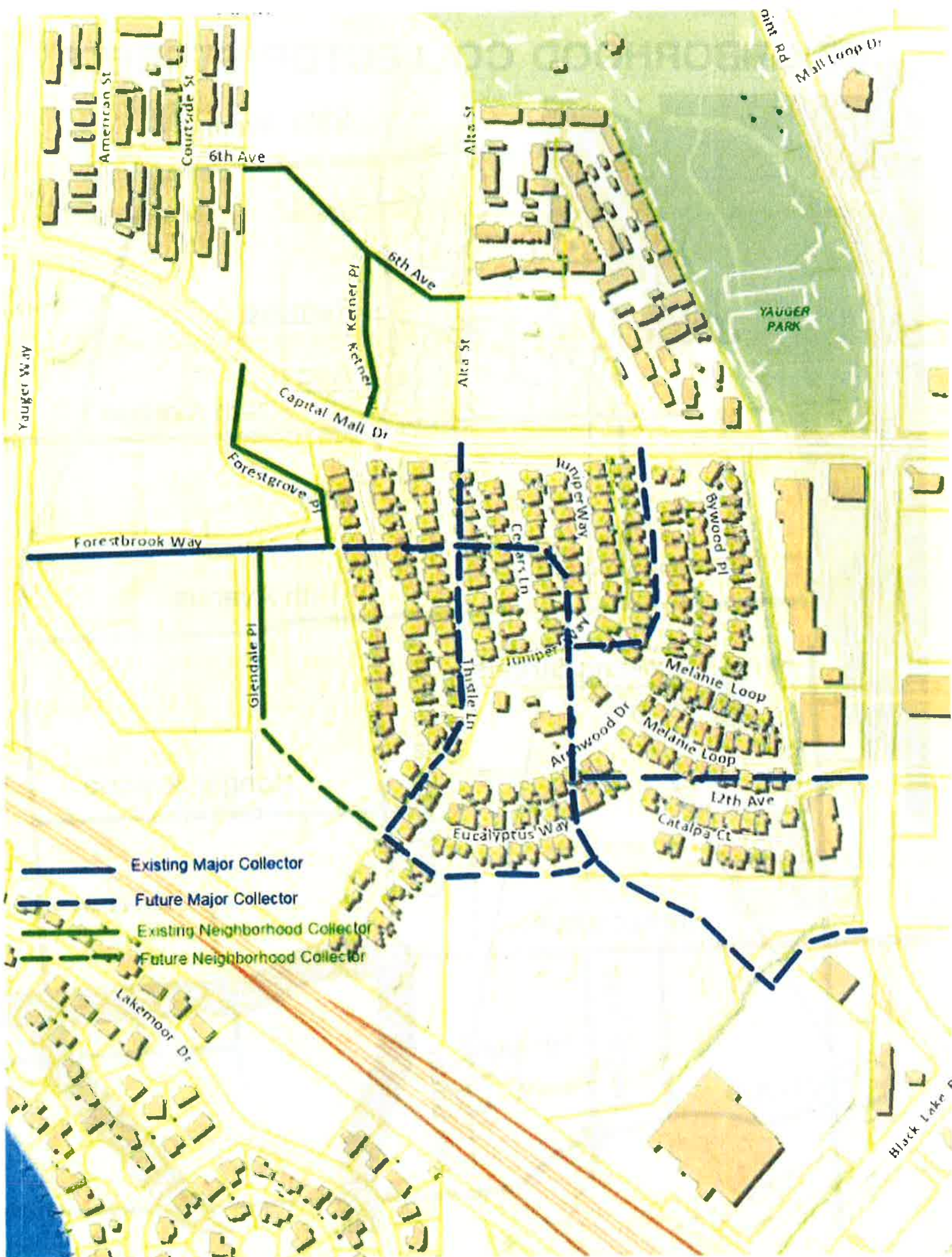
