Lauren Danner is being nominated to recognize her extensive research and scholarly approach in preparing a submission to place the Schmidt, Trueman and Virginia, House on the National Register of Historic Places (see attached 80 page submittal including extensive interviews with former owners of the house as well as original construction plans, photographs and newspaper clippings).
