25-0948 Update on Capital City Pride

Natalie Coblentz from Capital City Pride provided an overview of the organization's three day event in June and monthly events that not only celebrate the Queer community, but also hire and train artists in audio/tech, design branding, events and artistic growth. A couple of upcoming events include Queersgiving and New Year's Eve celebration involving 16 different artists and 5 different techs featuring drag dinner, comedy, music, burlesque and dancing.

Commissioners talked about artists spaces and places, understanding that cultural centers can be a key to artist livelihoods. Aside from the coming Armory for renting space, learning, teaching and networking, an inventory of downtown venues might also be part of the Olympia Downtown Creative District scope. Links to reservation sites with regional parks departments, schools, colleges and libraries can be added to the resource page on the City's public art site. The concept of the Arts Commission as convener or connector was explored as a way to help artists new to the community make connections. In the spirit of helping artists and arts organizations succeed, Ms. Johnson noted that a common thread among organizations that have recently met with the Arts Commission was a need for volunteers. She noted the ARCH Digest might be helpful in making those connections. Commissioners are invited to bring information about rental spaces and/or related information to the December meeting.
