1. CALL TO ORDER

The meeting was called to order at 5:58 p.m.

Chair Hart asked for two additions under Business Items:

14-1168 Approval of November 13, 2014 Arts Commission Minutes

6. BUSINESS ITEMS

15-0006 Review Positions of Chair and Vice-Chair

Commissioner Hinton noted other City boards and commissions use the term "Vice-Chair" instead of "Co-Chair," and said the first term is more fitting for Arts Commission positions.

Commissioner Westbrook moved, seconded by Commissioner Nelson, to retitle Arts Commission officer positions to Chair and Vice-Chair. The motion passed unanimously.

14-0982 Nominating Committee for 2015 OAC Officers

Commissioner Hinton shared the recommended slate of the nominating committee: Commissioner Jennings for Chair and Commissioner Hicks for Vice-Chair. Chair Hart opened the floor to additional nominations, but none were presented.

Commissioner Nelson moved, seconded by Commissioner Olson, to close nominations and approve the recommended slate of officers for 2015. The motion passed unanimously.

14-1177 Arts Walk Cover Artists 2015

Ms. Johnson reported 18 applications were reviewed by the jury consisting of Kristen Etmund, Kathy Strauss and Commissioner Perry. The Commission reviewed submitted work by photographer Duncan Green, the recommendation for spring, photo-collage artist Doyle Fanning for fall, and painter Greg Caudell, as alternate. Chair Hart noted the APP Committee reviewed the recommendation at their 5:00 p.m. meeting and accepted the jury's recommendation as their own. Commissioner Perry said the jury wishes to emphasize to applicant artists to keep submissions within one style so the jury knows what type of work to expect from each selected artist.

Commissioner Jennings moved, seconded by Commissioner Olson, to approve the APP recommendation for 2015 Arts Walk cover artists. The motion passed unanimously.

<u>15-0007</u> Olympia Artspace Alliance Allocation from the Municipal Art Fund

Chair Hart reported his discussion with Councilmember Selby regarding her intent to recommend to Council that \$50,000 from the Municipal Art Fund go to the Olympia Artspace Alliance. He invited Commissioners to share perspectives on the allocation. Commissioner Hinton recused himself from conversation because he is the Olympia Artspace Alliance Chair.

Chair Hart agreed to share the Commission's support with Councilmember Selby.

Commissioner Nelson moved, seconded by Commissioner Westbrook, to support the allocation of \$50,000 from the Municipal Art Fund to further the work of pre-development for the Artspace Project. The motion carried by the following vote:

14-1180 Municipal Art Plan 2015

Chair Hart noted only two Commissioners responded with changes or comments to the draft plan distributed last month. Commissioner Nelson said she appreciates the work of the Committee and trusts their recommendation. Commissioner Jennings noted a particular segment that needs work is the project list: intention, timeline, where they fit in the grand plan. Other Commissioners and staff felt a paragraph in front of the list would be sufficient, and that the list could be more general as each project will trigger its own process once approved. Commissioners agreed the document should be a five-year vision. Commissioner Jennings noted City Hall funds were not represented in the project list, which leaves it incomplete.

Commissioners Hicks, Jennings and Ms. Johnson will meet in December to continue work on the plan. The Art in Public Places (APP) Committee will meet January 8 at 5:00 p.m. in advance of the Arts Commission meeting, to work on a proposal for City Hall funds.
