# 6.A <u>17-0692</u> OHC Outreach Planning: 2017 Preservation Awards & 2018 Preservation Month

**6.B** <u>17-0851</u> Introduction to DOCOMOMO and Heritage Commission Involvement in Upcoming Tour Day in Olympia

Ms. Sadlier discussed an upcoming tour day being organized by the local chapter of the International Committee for Documentation and Conservation of buildings, sites and neighborhoods of the Modern Movement (DOCOMOMO). This year, the organization's tour day will take place in Olympia for the first time. She encouraged Heritage Commissioners to join colleagues at the State Department of Archaeology and Historic Preservation in taking part in the October 7, 2017 event as local hosts. Chair Kelly, Commissioner Davies, Commissioner Newmann and Commissioner Pratt stated they were interested in volunteering.

# 7.F Survey & Inventory Committee

Ms. Sadlier indicated she asked for an extension on the grant for the downtown survey because of delays in completing the work due to changes in the consultant firm's structure.

Ms. Sadlier is working on a request for proposals (RFP) for the Priest Point Park survey project. The search is for a company who has the expertise to cover the cultural, the historic, and the management plan aspects needed for the survey. She is also in the process of applying for a Thurston County grant to obtain an additional \$5,000 for this project.

# 7.G Staff

Ms. Sadlier provided updates on the following:

- The current study of the City of Olympia's arts, cultures, and heritage support and programming. Stakeholder and resource committees are being formed. Commissioner Helle is a member of the resource committee.

- Proposed code amendments in relation to a proposed State Environmental Policy Act (SEPA) exemption area in Downtown Olympia. Proposed changes would clarify and expand the role of Tribal and Agency consultation on potential impacts to cultural and historic resources with or without a SEPA process.

- Active Special Valuation agreements. The new list (distributed) will aide in the monitoring of the properties to ensure that owners are adhering to the rules of the program.
