<u>16-0337</u> Creative District

Responding to a request from the Arts Commission, Jill Barnes, Executive Director of the Washington Center for the Performing Arts, shared her experience as part of a Cultural District in Idaho Falls. She noted that a similar district for Olympia has the potential to animate the city and could be great if executed properly. Ms. Barnes noted that such a district needs resources to coordinate funding and partnerships. She observed that most arts organizations are strapped for time, and yet could benefit from the kind of collaboration a Creative District could provide. She shared some specific ideas and encouraged Commissioners to speak with other organizations as well:

-Ticket sampler

-Creative experiences (dancing in the crosswalks)

-Programming of public spaces ("Lindy" dance night).

-More free Wurlitzer concerts

-"No vacant storefront" policy

-Green spaces that improve the perception of safety

Chair Jennings observed that a Creative District might focus more on the relationships among creative entities that a physical place.

Commissioners thanked Ms. Barnes for sharing her observations and experience.
