## Ordinance No.

AN ORDINANCE of the City of Olympia, Washington, amending Ordinance No. 6800, appropriating funds within various Special Funds.

**WHEREAS**, the Olympia City Council appropriated funds within various Special Funds for the year 2012 by passing Ordinance No. 6779 on December 13, 2011; and
