21-0857      Cultural Access

Ms. Goddu shared the Cultural Access briefing she recently presented at City Council, outlining the goals and history of the legislation, which was created to expand access to the arts for all. She noted there is a planning process starting to put an "Inspire Olympia" measure on the April ballot, which could result in approximately \$2 million annually in sales tax revenue, similar to the recently passed Home Fund. Each community considering the tax has the opportunity to shape the use of the funds to provide the public benefit most needed in their community. The City plans to engage in public outreach efforts to determine the structure of funding best suited for Olympia, which will become the basis for the voter measure language.
