Initial Staff Comments on Draft Topics for Review

Commissioners Parker and Ingman discussed the letter they submitted to Councilmember Langer regarding their concerns about the Comprehensive Plan deliberations schedule. Councilmember Langer listened to the Commission's concerns and thought they were valid, but reiterated the Council's desire to have the Comprehensive Plan adopted according to the agreed upon schedule so the City may move onto the implementation strategy. Councilmember Langer expressed that a different strategy for completing some of the work would be to have the Coalition of Neighborhoods have a role. The Councilmember and Commission discussed the Coalition of Neighborhood's Memorandum of Understanding with the City pertaining to their role in the sub-area planning process. Councilmember Langer and Commissioner Reddick left at 7:33 PM The Commissioners discussed their deliberation schedule for the previously identified Comprehensive Plan topics and which issues should be included within each topic. There was a discussion about Commissioner Ingman's ideas around "programming documents." The agreed upon topics and dates for recommendation to the full Commission are: Foundations (Sept 17); Environment (Sept 24); Mobility and Land Use (Oct 1); Downtown (Oct 8); and Neighborhoods (Oct 15). The Commissioners affirmed their earlier decision to allow public comments during the deliberations for 30 minutes in the middle of the meeting and 30 minutes at the end. Remarks will be limited to three minutes.
