**6.B** 24-0624 Briefing by City Attorney Regarding Salary Commission Role and Duties

City Attorney Mark Barber was unable to attend. Human Resources Director Manny Bosser gave the briefing. He went over the role of the Salary Commission and some recent changes to the process in Ordinance 7383. The ordinance updated the original Salary Commission Ordinance, 7089.

The updates include: removing the obligation to hold Salary Commission meetings in the months of June and July; giving the Salary Commission the opportunity to receive a stipend to help defray costs for being on the Commission; and removing the requirement for Commissioner to be a citizen of the United States.
