#### 6. OTHER BUSINESS

**6.A** <u>13-0105</u> Approval of West Bay Sidewalk Public Art Design

Program Manager Stephanie Johnson and Arts Commission Chair Trent Hart reviewed public art proposals.

Councilmember Rogers suggested alternative funding for the art work.

City Manager Steve Hall said the ordinance allows one percent of major construction projects over \$500,000 to be used for art projects.

Councilmember Cooper moved, seconded by Councilmember Hankins, to approve public art design Walking on Land by Water by Carolyn Law for the West Bay Sidewalk Project. The motion carried by the following vote:

**6.B** Status Report on Planning Commission's Recommendation on Comprehensive Plan and Next Steps

Associate Planner Amy Buckler reviewed progress on the Comprehensive Plan to date. She said she is pleased to announce the Planning Commission completed their deliberations on schedule.

She noted the plan will be online May 20 along with online tools. She then reviewed next steps in the process.

Planning Commission Chair Jerry Parker reviewed major topics of the plan.

Councilmember Langer thanked everyone who worked so hard on this plan and noted the Land Use and Environment Committee will discuss this issue at this Thursday's meeting.

Councilmember Roe thanked members of the Planning Commission for their work and welcomed the new Chair. She suggested our website keep citizens up to date on the progress.

# **6.C** <u>13-0176</u> Continued Deliberation on the Shoreline Master Program

Community Planning and Development Director Keith Stahley reviewed the items to be covered in this evening's deliberations. These include:

Department of Enterprise Services (DES) issues

Heights

Stepbacks

West Bay planning process

Next steps

Council direction to staff

He noted the videos from last week's Mithun presentations are now online for viewing. Mr. Stahley gave a brief history of the West Bay area and provided details for the various issues.

#### **DES Issues** (Marathon Park)

- Trail and road will be maintained.
- Restroom may be relocated.
- Impacts on future dredge operations on the lake will be minimal.

#### Heights

- A map was shown indicating various heights along the shoreline.
- On West Bay Drive, the view blockage can only be up to 45 percent, and the height is limited to 42 feet, but by providing a waterfront trail, this can be increased.

#### **Buffers and Setbacks**

- There are no changes to the setbacks as previously identified.

#### **West Bay Planning Process**

- This is a unique plan and led to the West Bay Drive Design Review Standards, included in the development regulations.
- These can be amended through the zoning code amendment process, i.e., stepbacks.

Mayor Buxbaum asked to add a discussion about incentives and priorities by reach.

## Discussion on the trail and incentives to provide a trail

- There is no requirement to provide a trail.
- If a waterfront trail is installed, there could be blockage of up to 70 percent of view from West Bay Drive and a maximum building height of 42 feet. If higher than 42 feet, then only 45 percent blockage is allowed. Also, anything over 42 feet would need to include a residential component.
- Having a trail and access to the water is critical.
- Stepbacks and design review will have an impact on view blockage.

Mayor Pro Tem Jones suggested a change to height limitations on Reach 6A between Marine Drive and Olympia Avenue, allowing greater height allowances as you move farther from the waterfront.

After considerable discussion on this issue, Mayor Pro Tem Jones moved, seconded by Councilmember Roe, that in reach 6A, height restrictions be established in the first 100 feet upland from the ordinary high water mark to a limit of 35 feet; the next 50 feet landward be limited to 45 feet in height; and the remainder of the shoreline jurisdiction be allowed to reach the full 65 foot height. The motion failed by the following vote:

Aye: 3 - Mayor Pro Tem Jones, Councilmember Cooper and Councilmember Roe

Nay: 4 - Mayor Buxbaum, Councilmember Hankins, Councilmember Langer and Councilmember Rogers

Mayor Pro Tem Jones suggested the stepbacks be made a part of the City's design standards instead of the Shoreline Master Program. Council agreed.

Mayor Pro Tem Jones suggested including a full sized urban pathway 12 feet or wider with 24-hour public access and a more natural shoreline within the Budd Inlet shoreline. Council agreed.

Mayor Buxbaum stated the west side of the Bayview parking lot has a steep rip rap wall. Beyond that is Percival Landing on piers, which is not sustainable. He suggested a better solution would be to bring the boardwalk to the shoreline as has been done on Percival Landing behind the Les Schwab building. He said he is looking for continuing what we've done in Phase II of Percival Landing through a public/private partnership and would like to incentivize a continuation or extension of this form of Phase II all around Percival Landing to the 4th Avenue Bridge.

Mayor Pro Tem Jones suggested that the development standards might address orientation.

With regard to Reaches 4 and 5A, Council agreed that the area from the 5th Avenue Bridge to the Port Plaza would be designated commercial waterfront, which is scaled to people on the waterfront side and attractive with amenities that attract quality development to the area.

Other suggested incentives include a softened shoreline on Reach 5A, and physical access to the shoreline.

Council agreed to ask staff to bring back the incentives for 4, 5A, and 5C in the next draft, which will include flexibility, clarity, and definitions regarding setbacks.

#### **NEXT STEPS**

Mr. Stahley noted the next draft will come forward to Council on May 14.

Mayor Pro Tem Jones suggested a change to the timeline which would allow the written record to stay open an additional one to two weeks, and then hold a public hearing. Staff agreed to look at the process and bring back a revised timeline in April.

Councilmember Langer suggested the candidates for the Hearing Examiner position who were not appointed be added to the Pro Tem list.

Mayor Buxbaum noted the Finance Committee met and agreed to approve moving forward with funding the LED street light conversion program.

#### 8.B CITY MANAGER'S REPORT AND REFERRALS

Mr. Hall said the City is replacing the sewer pump at Percival Landing and the bid award will come to Council on a future agenda.
