We are the owners and occupants of the house located at 430 Stoll Rd SE, Olympia, WA 98501, right at the corner of Stoll Rd SE and Stoll Rd SE.

We received your letter dated January 31, 2020 informing us of the city's proposal to rename our street and requesting two road name suggestions. We have actually three new name suggestions to provide.

Until they passed away, our neighbors across the street from our house (formerly at 431 Stoll Rd SE, Olympia; currently it is the new apartment building development) were Mr. Franz Anderson and his wife Mrs. Ruby Anderson. Mr. and Mrs. Anderson were the very first and the only owners of the entire area at Stoll Rd SE, from Lilly Rd SE to the end of Stoll Rd SE and from Interstate 5 all the way to Martin Way E. It was

probably about 100 years ago that they came to live at 431 Stoll Rd SE and were the only owners of everything on Stoll Road.
