Announcements

Mayor Mah noted the Executive Session that was previously scheduled was cancelled.

Approval of Agenda

Mayor Pro Tem Buxbaum moved, seconded by Councilmember Roe, to approve the agenda. Motion passed unanimously.

SPECIAL RECOGNITION Community Garden Update

Program Specialist Louise Webb provided an update of the City's first Community Garden near Yauger Park which has 69 plots and many gardeners on the wait list.

PUBLIC COMMUNICATION

Mr. Jerry Kovis, 1311 Eastside Street, complained of speeding traffic in residential areas. He also stated he believes it should be easier for individuals to busk in the downtown areas.

Jacob, 147 Milroy, spoke in support of busking.

Joseph A, a busker, said busking is his livelihood and asked that it be made easier for him to do this.

Mr. Drew Hendricks, 816 Adams, spoke of police intimidation by standing in the foyer of City Hall tonight and said a culture of mistrust exists between the Police Department and individuals on the street.

Mr. Jason Leher, 224 Cushing St. NW, spoke in favor of a classless environment downtown.

Mr. Charlie Bishop, 555 West Bay Drive NW, said he plans to become involved and will be attending Council meetings.

Mr. Jack Gibbs, spoke of equality for everyone and said there is too much harassment of buskers.

Mr. Jeff Aggen came to the microphone but chose not to speak.

Mr. Stephen Hunt Ogden, 1425 Foxfire Dr. SE, spoke of the diversity of Olympia.

Ms. Annastezhaa Curtis spoke of the virtues of providing music through busking.

Ms. Brittney Kakoe, spoke in favor of busking.

Mr. James Laird, spoke in favor of busking.

Ms. Brittney Jones said she believes buskers should be able to perform anywhere without harassment.

Mayor Mah said the remaining individuals who have signed up may speak at the end of the meeting.

COUNCIL RESPONSE TO PUBLIC COMMUNICATIONS

Councilmember Strub thanked those who spoke tonight. She asked staff to provide a brief history of the busking restrictions. She noted many people have complained to her that they don't feel safe downtown but did not complain about the music.

City Manager Steve Hall said the current busking ordinance was passed in 2007 to provide a balance in the downtown, and to keep the sidewalk and business entrances clear. He stated staff is looking at providing more busking areas and will produce and provide a brochure to individuals, businesses, and police so everyone will be aware of what is allowed.

Councilmember Strub asked to refer the busking ordinance to the General Government Committee. Councilmember Ottavelli stated he believes this should be referred to Planning Commission. Councilmember Langer said the Land Use and Environment Committee strives to work together to make downtown very livable. He said he would accept the referral to the Land Use and Environment Committee to review the busking rules.

Mayor Mah said the item will be referred to the Land Use and Environment Committee.

CONTINUED PUBLIC COMMUNICATIONS

Mr. Mike Coday, Chehalis, spoke of the right to free speech and expression. He said he is gathering signatures and asking the City to repeal the busking ordinance.

Mr. Charles Garret, 614 Pear St. NE, thanked the City for helping to clean up his neighborhood near the corner of Glass Ave. and East Bay Drive.

Mr. Scott Roberts, Property Rights Director for the Freedom Rights Organization, spoke on the community renewal law. He addressed the issue of blight and suggested the City use current staff to identify blight rather than hire a consultant.

Mr. Glen Morgan, Tenino, Project Manager for Stop Taking our Property Thurston County, spoke of the efforts by the City to use the eminent domain law to remove blight.

Ms. Maureen, an area artist who works with homeless youth, spoke of mistreatment of these youth and the lack of housing and facilities for them.

Councilmember Strub noted the City has not spent any money for a consultant.

Councilmember Rogers agreed that the City could identify its own blight.
