Capital Facilities Plan - Make recommendation to Olympia Planning Commission on the draft 2013-2018 Capital Facilities Plan.

Dave Okerlund, Parks Planning Program Manager, gave a status update on the Capital Facilities Plan (CFP). The Boys and Girls Club will not be constructing the new building in part of Woodruff Park; however, a shared use parking lot will be constructed there. The Council is also looking at possibly purchasing parcels on the Isthmus and may want to have funds available in case all proposed funding is not received, i.e. state grant, fundraising.

Mr. Okerlund proposed that the Committee postpone their recommendation on the CFP until projects are finalized in the next few months. The Committee discussed the Isthmus properties and the impact this proposed diversion of funds will have on other park projects.

The Committee agreed to postpone its recommendation.

Park Impact Fee Rate Study - Make recommendation to City Council regarding the draft Park Impact Fee Rate Study.

Mr. Turlove gave a PowerPoint presentation on the draft Park Impact Fee Rate Study. The presentation included a review of the current and proposed park impact fee rates. The presentation was followed by Committee discussion.
