Notice of Public Hearing

Notice is hereby given that the City of Olympia, Washington (the "City") will hold an open public hearing for the purpose of hearing comments from the public regarding a plan of finance for the issuance by the City of one or more series of tax-exempt obligations (the "Bonds"), to finance capital improvements to the Hands On Children's Museum (the "Museum"), as described below. The Bonds may be issued in one or more series from time to time and may include series of refunding obligations.

The public hearing will be held on July 8, 2025, starting at 6:00 p.m. Pacific time or as soon thereafter as possible, and can be attended virtually or inperson at City Hall, 610 4th Ave East, Olympia, WA. The hearing will be held in

Council Chambers. To attend via Zoom, use the link below. Comments will be accepted in writing, in person, or via Zoom – all are equally acceptable.

The City may designate all or a portion of the Bonds as "qualified 501(c)(3) bonds" under Section 145 the Internal Revenue Code of 1986, as amended (the "Code"). Proceeds will be used to finance the design, construction, development and improvement of an expansion of the Museum, capitalize interest on the Bonds, and to pay the costs of issuing the Bonds (the "Project"), located at 414 Jefferson St NE, Olympia, Washington 98501. The Project will be owned by the City and primarily managed and operated by the Hands On Children's Museum, a Washington nonprofit corporation. The maximum principal amount of Bonds expected to be issued for the Project within the next three years is \$25,000,000 (in one or more series).

Comments will be heard from all interested parties attending the hearing. Written comments prior to the hearing may be directed to the City at 401 Union Street, Suite 1600, Seattle, Washington, 98101, Attention: Deanna Gregory, Pacifica Law Group.
