- Deschutes Estuary restoration project leadership: PN4.4 Updated language confirmed.
- Urban forestry: Tree canopy goal setting; pocket forests vs. street trees captured in PN3.1 Develop an Urban Forest Management Plan, balancing sustainable growth with environmental protection.
- Environmental Monitoring: Captured in PN2.9 "Evaluate, monitor, and measure environmental conditions. Use this data, along with best available science, to develop short and long-term management strategies."

- PN 3.1 "Develop an Urban Forest Management Plan to establish tree canopy goals and inform the policies, programs, operations, and resources needed to implement those goals." Added to this policy, "The strategies described will strike a balance between environmental protection and sustainable urban growth."
- PN 4.1 Replaced "local Tribes" with "Squaxin Island Tribe" re: collaboration on improving the health of Budd Inlet.
- PN 4.4 Replaced "Remain engaged as a key stakeholder" with "Continue to champion" re: future phases of the Deschutes Estuary restoration project.
