Free Access to Ballet Northwest's 50th Anniversary Production

## **Q3** Project Summary

The upcoming year is a particularly exciting one for Ballet Northwest (BNW), as we are preparing to celebrate the company's 50th year of contributing to the artistic and cultural life of Southwest Washington. In honor of this milestone, BNW is producing five world premiere dances set to famous orchestral works with live accompaniment by members of the Olympia Symphony. Performances will take place May 8-10, 2020 at the Washington Center for the Performing Arts, and will include paid performances (with 200 free tickets distributed to low-income and at-risk families) as well as a free matinee performance for students and teachers from regional elementary schools.

The production, called Crescendo, will consist of American in Paris Suite by George Gershwin, Bolero by Maurice Ravel, Hungarian Dance by Johannes Brahms, The Four Seasons by Antonio Vivaldi, and a suite of dances from the famous classical ballet La Bayadere, choreographed by Marius Petipa with music by Leon Minkus.

## Q7 How does your Arts/Culture Organization's prior experience ensure a successful project?

This production will celebrate and build upon BNW's long history of success. Founded in 1970, BNW is the sole nonprofit ballet company in Thurston County and the oldest in Washington State. As a community-based company dedicated to dance as a performing art, BNW produces five productions annually, including The Nutcracker, a varying spring production over Mother's Day weekend (Crescendo in 2020), the Olympia Dance Festival, the Young Choreographers Showcase, and a guest professional company performance.

The project will be led by husband and wife team Ken and Josie Johnson, who have served as BNW's Co-Artistic Directors since 2008. They both danced professionally, have degrees from the Hartt School, and are American Ballet Theatre certified teachers. They also co-direct the Johansen Olympia Dance Center. Key partners include the Washington Center, Olympia Symphony, BNW's resident costume designer Karen Bramwell (studied at Pacific Northwest Ballet's costume shop in Seattle), resident set designer Jill Carter (studied at American Conservatory Theater in San Francisco), and resident lighting designer Roger McIntosh (studied at Jacob's Pillow Dance Festival in Massachusetts).

### Q8 Please describe your audience. Please share in what ways this project will reach under-served communities.

While the 50th production will draw many of our mainstay audiences, such as friends and family of company dancers, BNW members, and regional ballet enthusiasts, we also expect to draw bigger and more varied crowds than we typically see for our spring show. For example, we are kicking of our 50th anniversary with a gala event in January that aims to reconnect BNW alumni with the organization. We hope to see many of them at Crescendo, as well as supporters of the Olympia Symphony who are excited to see our two organizations collaborate.

As always, we are committed to expanding our audience beyond those who typically attend arts performances of any kind. In fact, making the art of dance accessible to all children and families, particularly those who are low-income and at-risk, is one of our board's top priorities. Through our multifaceted Dance Access Initiative, we serve about 2,000 children and their parents, caregivers, and teachers each year by providing free performance tickets, a free student matinee performance and in-school assemblies, and dance scholarships.

To get tickets to families in need for this special production, we will work with our established community partners including Big Brothers Big Sisters, Community Youth Services, Family Support Center, Family Education and Support Services, YWCA, Homeless Backpacks, SafePlace, and tribal organizations.

### Q9 Please summarize the public benefit of your proposed project.

BNW's overarching goal is to keep ballet alive and thriving in Southwest Washington by providing high-quality productions that engage and educate the community, while giving young dancers the opportunity to develop and showcase their skills. The 50th anniversary production will delight both our dancers and audiences with a varied program of both classical and contemporary dance. This provides a contrast to the more traditional, widely available staples of the repertory such as Swan Lake and Sleeping Beauty.

The opportunity to see a world premier ballet production of this caliber in a city the size of Olympia is a truly unique opportunity. We are excited to be bringing exceptional guest choreographers from all over the world, including Laney Engelhard (former dancer, American Repertory Ballet), Xijun Fu (former dancer, National Ballet of China), Suzanne Haag (resident choreographer, Eugene Ballet), Joanne Holbrook (South African master teacher & choreographer), Rachael Parnell (BFA, The Hartt School, University of Hartford), Matthew Pawlicki-Sinclair (Soloist, Oregon Ballet Theatre), and Justine Sheedy-Kramer (University of Utah).

## Q10 How does this project expand or build upon the arts in our community?

BNW's collaboration with the Olympia Symphony to provide live musical accompaniment is a particularly exciting element of this production. This merging of live music and dance is something BNW has done in the past with great success. While the high cost and logistical challenges of collaborative productions limit their frequency, we are thrilled to offer Southwest Washington audiences the chance to see live music and dance together, an opportunity that is very rare outside major cities like Seattle and San Francisco. In the past, we have found that these partnerships not only boost production caliber, but also broaden our audience by drawing the supporters of our partner organizations.
