7. REPORTS

City of Olympia staff reported on RFP active on sea level rise adaptive management and monitoring. Deadline was June 2nd, five consultant applications are being considered and SLR committee will be kept updated on the process. Ms. Clark and the City Stormwater engineer met with representatives of the Department of Ecology about a contract for an upcoming project.

Port staff reported that the Port are monitoring ongoing erosion along East Bay as well as installing backflow prevention on stormwater outfalls during the next 5 year plan as well as monitoring and replacing outfalls into 2026.

LOTT staff reported on looking at hydraulics at the wastewater treatment plant. They also discussed a pipeline with a bottleneck that is in the design contract phase, and hoping to have construction for the replacement to begin in 2026. They have final draft for greenhouse gas inventory for 2024, and were awarded a clean building performance standard for regional services building.

Squaxin reported on a presentation by Richard Freeman regarding outfall and ocean acidification.
