1. CALL TO ORDER

Meeting was called to order at 6:02 p.m.

Boards & Commissions

City Attorney Tom Morrill spoke with members on expectations for advisory committee members regarding open meetings. He also noted there are new requirements for notices of special meetings. With regards to public records Tom reminded Commissioners to avoid email conversations (do not "Reply All"), keep Arts

6. BUSINESS ITEMS

12-0710 2013 Work Plan Development

Commissioners discussed items for the 2013 Work Plan. Most items from the 2012 plan were kept, with slight modifications, and additions include supporting the Artspace Market Survey, and the proposal to increase the number of Arts Commission meetings for 2013. Staff will update the Work Plan matrix for approval at the January 8, 2013 meeting.

The work plan was discussed and closed.

12-0711 2013 Chair Nominations

Does the Arts Commission move to approve the recommendation of the nominating committee of Chair and Co-Chair for 2013?

Kelsey shared the nominating committee recommendations for 2013: Trent and Ron for Chair and Co-Chair, respectively. A motion was made by Commissioner Rick Perry, seconded by Co-Chair Sarah Burdock Segall, that the motion be approved. The motion carried by an unanimous vote. The motion was passed unanimously.

In addition, Sarah announced that she will be stepping down from the Commission at the end of 2012, because of increased responsibilities in her non-Commission life. She shared that she enjoyed her time on the Commission and members shared their appreciation for her contributions of the past 2 terms.

Commissioner Perry moved, seconded by Co-Chair Burdock Segall, to approve the motion. Motion passed unanimously.

7. REPORTS

<u>12-0712</u> Art in Public Places Committee Report

Commissioner Hart provided the report for the Committee:

- The proposed site for Windstar is ready to go to Council. At the August meeting, Commissioners approved both Yauger Park and Port Plaza sites, pending more research. Having communicated with both the artist and Port staff, the Port Plaza site will go forth as the preferred location.
- The Committee looked at staff's evaluation of the 2012 plinth project. The Committee will add their own observations at the next meeting and make recommendations of proposed changes, if any, to the full Commission.
- The Committee reviewed changes the Commission had made to the Gift Policy and have directed staff to send the changes to the City Manager.
- The Committee has asked staff to provide a professional condition report for the Public Works Employee Tribute. The Commission's yearly condition reports flagged

those sculptures as being in bad shape. A conservator's report will help inform a recommendation from the Committee for conservation or deaccession.

- The Commission has been asked to provide an issue paper regarding public art projects Citywide. Commissioner Hart will kick-off that effort for the next Commission meeting.
- The Committee will also start discussing the 2013 Municipal Art Plan, which will go to the full Commission for recommendation to Council.
- The dedication for "The Call of Duty" at Fire Station 4 will take place on November 15, at 4:00 p.m.

The report was received.

12-0713 Community Events & Outreach Committee Report

Commissioner Perry provided the report for the Committee:

- -He reviewed response from the Arts Walk evaluations. Most responses were positive. Feedback on the quality of promotions has slipped from primarily excellent to good, so staff will keep that in consideration for the future.
- -He asked Commissioners to send Stephanie websites of area arts organizations to add a resource guide to the Arts Commission web page.
- -He noted that the Arts Digest had changed format, moving from attachments to keeping the information in the body of the email. Response so far has been good. He is also interested in archiving Arts Digests on the Arts Commission web page as well. Staff is looking into it.

The report was received.

<u>12-0714</u> Arts Organization Liaison Report

Co-Chair Burdock Segall shared that she attended the annual PBIA meeting. There was a recap of projects done by the group including the Artesian Well mosaic and Canoe Journey mural. There was also comment and praise for the Plinth Project. She noted that the PBIA intends to purchase RING DANCE #2/CORE by Don Freas and install it in downtown Olympia following the exhibition.

The report was received.

<u>12-0715</u> Music Impact Survey Phase II Report

This topic was originally scheduled for discussion at the July 12, 2012 meeting but was postponed at that time to a future meeting. (see File 12-0336)

Commissioner Olson reported he continues to work with Riley Moore at St. Martin's University on Phase II of the Music Impact Study. They plan to reduce the scope of the survey from Thurston County to just Olympia to make it more manageable.
