Those interviews will be held in early- to mid-March on dates to be set.

Chair Roe asked staff to review applications from prior years to determine possible continued interest. Councilmember Cooper asked staff to contact Joel Hansen with PRAC to ask if he is interested in reappointment.

Committee members agreed that they did not need to set a date to interview the Lodging Tax Advisory Committee members whose terms have ended. Instead they will recommend reappointment for those individuals: Nathan Allan, Russ Carstensen, and Greg Taylor.
