Background:

Based on Civil Service Rule V, Registers, Initial Eligibility Lists, initial eligibility lists were established with candidates who applied through Workday and met position qualifications. Seven (7) candidates applied. Four (4) did not meet qualifications and three (3) candidates were invited to interview. Three (3) candidates participated in the interview and three (3) candidates passed. Three (3) have been placed on the register.

One (1) candidate was Male and two (2) candidates were Female. Three (3) candidates were White/Caucasian. Two (2) candidates were external and one (1) candidate was internal. The interview panel consisted of OFD Chief Matt Morris, OFD Deputy Chief Mark Schreck, OFD Acting MSO Captain Troy Churwell, OFD Firefighter Craig Meyer, and Community Member Bev Miller-Todd.

Findings:

Three (3) candidates have successfully passed the interview and have been placed on the register in accordance with scores of 82.10-91.45.

Background:

Based on Civil Service Rule V, Registers, Initial Eligibility Lists, initial eligibility lists were established with candidates who passed the Public Safety Testing written and physical exams. Fifty-four (54) candidates were invited to the phase 1 suitability assessment. Twenty-eight (28) participated in the phase 1 suitability assessment, and ten (10) passed. Ten (10) candidates were invited to oral interview, one (1) candidate withdrew, two (2) did not respond to the invite, two (2) were unable to make the scheduled date and will be offered another opportunity, five (5) participated. Four (4) candidates passed the oral interview.

Three (3) candidates were Male and one (1) candidate was Female. Two (2) candidates were Two or More Races, one (1) candidate was Asian/Pacific Islander and one (1) was White/Caucasian. The interview panel consisted of OPD Sergeant Eric Henrichsen, OPD Officer Alex Watkins and Community Member Rance Leaders.

Findings:

Four (4) candidates passed the phase 1 suitability assessment and the oral interview and has been placed with the one (1) outstanding candidate on the register in accordance with scores of 80.29 - 88.17.
