5. ANNOUNCEMENTS FROM UAC AND STAFF

Chair Lamson thanked Committee member Bloom for chairing the October 3 UAC meeting.

Water Resources Director Barham provided the following updates:

Vice Chair Sherry Chilcutt unfortunately resigned from the UAC due to family reasons. The City will now recruit for three vacancies on the UAC. The recruitment period is open, with applications accepted through December 13.

Ask planning staff if a recommendation is needed from the UAC for the Natural Environment chapter of the Comp Plan. If yes, this business item would be brought to the UAC at the February 2025 meeting.

Reminder of the LOTT Treatment Plant tour scheduled for November 15 for the three UAC members that signed up.

Drinking Water Utility Director Vessey provided current data on the City's two Utility Assistance Programs. The Helping Neighbor Program is not being used to full capacity and staff are reviewing barriers and communication strategies. Staff will add a program update to the UAC's 2025-2026 workplan. Chair Lamson asked if could gather data on how many customers are eligible but not aware or using the assistance programs.

Information about Council items such as Public Hearings on the 2025 Budget and Capital Facilities Plan, special recognition of the Street Sweeper Decal Student Artist Contest and the seven year renewal of the Regional Environmental and Education Programs (Stream Team) Interlocal Agreement with Lacey, Tumwater, Olympia and Thurston County.

Staff is preparing for king tides in mid-November through early March. Visit the Clty's Downtown flooding webpage for more information and also opt-in to Thurston County alerts for Budd Inlet.

Asked if UAC members are interested in continuing to receive hard copies of the staff powerpoint presentations during the meetings. Committee members expressed that they would like to continue receiving copies.
