1. CALL TO ORDER

Chair Brown called the meeting to order at 6:30 p.m.

2. APPROVAL OF AGENDA

The agenda was approved.

3. APPROVAL OF MINUTES

3.A [15-0181](#) Approval of January 26, 2015, Planning Commission Meeting Minutes

The minutes were approved.

4. PUBLIC COMMENT - None

5. STAFF ANNOUNCEMENTS AND COMMISSION INFO REQUESTS

Mr. Stamm announced pending development projects in the Downtown area. He responded to questions from Commissioner Parker about the Comprehensive Plan (CP) amendment proposal public outreach process. He explained procedures for screening CP amendments and discussed the timeline for a downtown strategy with review by the Land Use and Environment Committee (LUEC). He outlined how the

plan provides a vision and set of broad guidelines, but a strategy is a set of specific techniques used to realize the Plan.

Chair Brown discussed communications about the Capital Facilities Element and CFP goals with staff and councilmembers.

Mr. Stamm answered questions about the status of PC retreat communication protocol follow up.

6. BUSINESS ITEMS

6.A [15-0179](#) Proposed Amendments to Wireless Communication Facilities Code - Deliberation and Action

Mr. Stamm reviewed the PC September 8, 2014 public hearing responses to the proposal from AT&T to revise the City's development code. He discussed how the evaluation by City legal counsel and staff analysis of federal regulations could have a substantial effect upon the proposed amendment.

Commissioner Parker moved, seconded by Commissioner Richmond, to table the proposal pending legal counsel report and a future decision by the PC to schedule another public hearing to present an alternative proposal.

6.B [15-0178](#) Collection of Rezone Proposals - Deliberation and Action

Olympia Municipal Code Chapter 18.58 - Rezones and Text Amendments

New Section OMC 18.58.040 Collection of rezone applications

Site-specific rezone applications may be submitted at any time. However, for review purposes such proposals will be collected into two sets in each calendar year. One set will be those submitted prior to the submittal deadline established by the City Council for annual Comprehensive Plan amendments and will be considered concurrently with such amendments. A second set will be based on a second submittal deadline set by the City Council. Accordingly, unless otherwise specifically authorized by the City Council, site specific rezone proposals shall be considered collectively and no more than twice each year. Time limits for review of the first set shall accord with any time limits for review of Plan amendments; the time limit for review of the second set shall be as established in OMC 18.72.120 provided that the review period shall start on the 'due date' established by Council and not the date of application.

The Commission discussed the language for consistency with the CP.

Chair Brown moved, seconded by Commissioner Bateman, to adopt the amendment language as written. The motion passed unanimously.

6.C [15-0180](#) Planning Commission Appointments to PRAC and UAC - Discussion

Chair Brown discussed Planning Commission appointments of one of its members to each of the Utility Advisory Committee (UAC) and Parks and Recreation Advisory Committee (PRAC). The Commission discussed the possibility by the City Council

General Government Committee to reduce the membership of these Committees from 11 to nine members each.

Commissioners concurred with a nine member status and continuance of non-voting liaison assignments.

The discussion was completed.

7. REPORTS

Commissioner Richmond attended the Utilities Advisory Committee and gave a report.

Commissioner Horn and Mr. Stamm attended the meeting facilitated by the Ruckelshaus Center about the Capitol Lake estuary situation and gave a report. They also attended a meeting on Downtown parking problems organized by the Olympia Downtown Association and gave a report.

Commissioner Parker discussed comments on the Westside neighborhood email list.

Commissioners Horn and Parker met with Joe Ford and City staff to discuss bicycle boulevards.

Chair Brown gave a leadership team report and suggested canceling the next PC meeting.

Commissioner Hoppe attended a Parks and Recreation meeting and gave a report.
