AN ORDINANCE OF THE CITY OF OLYMPIA, WASHINGTON, AMENDING TRANSPORTATION IMPACT FEES, AND AMENDING SECTION 15.16.040, SCHEDULE D, OF THE OLYMPIA MUNICIPAL CODE.

WHEREAS, the City Council adopted Ordinance No. 6938 on December 16, 2014, amending transportation impact fees and amending Section 15.16.040, Schedule D, of the Olympia Municipal Code; and

WHEREAS, after approval of Ordinance No. 6938, staff identified an error in the Marina Land Use Rate in Section 15.16.040, Schedule D, of the ordinance; and

WHEREAS, it is in the best interest of the City to correct and increase the Marina Land Use Rate as intended so that project costs will remain current with the cost of labor, construction materials and real property; and

WHEREAS, this Ordinance is adopted pursuant to Article 11 Section 11 of the Washington State Constitution and any other applicable authority; and

WHEREAS, this Ordinance is supported by the staff report, attachments, and documents on file with the City, and the professional judgment of staff;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL ORDAINS AS FOLLOWS:

Section 1. <u>Amendment of OMC 15.16.040</u>. Section 15.16.040 of the Olympia Municipal Code is hereby amended to read as follows:

3) Downtown Services/Retail includes Retail Stores, Restaurants, Supermarkets, Convenience Markets, Video Rentals, Banks, Health Clubs, Day Cares, and Libraries.

Section 2. <u>Severability</u>. The provisions of this Ordinance are declared separate and severable. If any provision of this Ordinance or its application to any person or circumstance is held invalid, the remainder of this Ordinance or application of the provision to other persons or circumstances, shall be unaffected.

Section 3. <u>**Ratification**</u>. Any act consistent with the authority and prior to the effective date of this Ordinance is hereby ratified and affirmed.

Section 4. <u>Effective Date</u>. This Ordinance shall take effect five (5) days after publication, as provided by law.
