#### 2. STUDY SESSION

## **2.A** 13-0661 Review of Oral and Written Comments on the Shoreline Master Program (SMP)

Mayor Buxbaum noted that Community Planning and Development Director Keith Stahley had provided a list of issues for tonight's discussion. Mayor Buxbaum then reviewed the process for the discussion.

Councilmembers discussed the issues proposed by staff as well as additional items.

Consensus was reached on changes to wording and those changes will be brought forward in the final draft to be presented to Council on September 17.

Changes on five issues within Table 6.1 will be acted upon under Other Business directly following the Study Session.

Mr. Stahley reviewed the five issues to be voted on within Table 6.1.
