- 3. Describe your involvement in the Olympia Community. Since opening Olylmages Studio here, I have been a teacher and mentor for young and mature artists. I have fulfilled commissions, offered group and private classes and held meetings for art groups in my studio. For the past four years I have chaired the Olympia Art League Lakefair Juried Show and rescued it from abandonment to solvency. I and my students have shown work in every Art Walk since 2008. I received a grant for anamorphic chalk art from the State Capital Museum. I have served as an art juror for the Thurston County Fair for the past two years. I have participated in Pecha Kucha sessions and marched in the Procession of the Species parade. I've enjoyed all of this ...


