**13-0806** Music Survey Phase II Presentation

Michael introduced Dr. Riley Moore from St. Martin's University to report on Phase II of the Economic Value of Olympia's Music Industry. Building on the report done by MPA students at The Evergreen State College in 2010, which examined only labor, Dr. Moore examined

Employment, Income and Output Impacts for the Olympia area, Thurston County, Thurston, Pierce and King Counties, and Washington State. In addition to the NAICS sectors used in the Phase I study, Dr. Moore added another 479 industry categories to the mix, facilitating a more localized assessment down to the zip code level. Dr. Moore noted estimated costs of a survey for households and businesses would be +/- \$15,000.
