

RESOLUTION NO. M-2668

A RESOLUTION OF THE CITY OF OLYMPIA, WASHINGTON, SETTING DECEMBER 9, 2025, AS THE DATE FOR A PUBLIC HEARING ON A PROPOSAL TO VACATE AS A PUBLIC THOROUGHFARE AN ALLEY SOUTH OF LEGION WAY, BETWEEN ADAMS STREET AND JEFFERSON STREET

WHEREAS, OMC 12.16.050 and RCW 35.79.010 require the City Council to adopt a resolution that sets a public hearing date for the consideration of a right-of-way vacation request; and

WHEREAS, the Olympia City Council has determined that a public hearing should be held regarding the proposal to vacate an alley south of Legion Way, between Adams Street and Jefferson Street; and

WHEREAS, one of the purposes of this Resolution is to provide notice to residents and neighbors of the proposed alley vacation and to give the public an opportunity to provide testimony and comment on the vacation petition to Council;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL HEREBY RESOLVES AS FOLLOWS:

Section 1. The City Council, pursuant to OMC 12.016.050 and RCW 35.79.010, hereby initiates the holding of a public hearing on whether to vacate as a public thoroughfare the following legally described property:

THAT PORTION OF THE EAST-WEST ALLEY ADJACENT TO LOTS 4 AND 5 OF BLOCK 46 OF SYLVESTER'S PLAT AS RECORDED IN VOLUME 1 OF PLATS, PAGE 14, RECORDS OF THURSTON COUNTY, WASHINGTON, LYING WESTERLY OF JEFFERSON ST AND ADJACENT TO AND EASTERLY OF ALLEY VACATION 1282 IN SAID BLOCK 46 (BEING APPROXIMATELY 10 FEET WIDE BY 60 FEET LONG);

TOGETHER WITH THE EAST HALF OF THE NORTH-SOUTH ALLEY IN SAID BLOCK 46, LYING SOUTH OF THE NORTH LINE OF THE EAST-WEST ALLEY OF SAID BLOCK 46 AND LYING NORTH OF THE SOUTH LINE OF SAID EAST-WEST ALLEY (BEING APPROXIMATELY 10 FEET WIDE BY 5 FEET LONG);

SITUATE IN THE CITY OF OLYMPIA, COUNTY OF THURSTON, STATE OF WASHINGTON.

Section 2. December 9, 2025, at 6:00 p.m., or thereafter, as stated upon the City Council's agenda, at the Olympia City Hall Council Chambers, 601 4th Avenue E, Olympia, Washington, is set as the time and place for the public hearing on the proposed alley vacation, such date being not fewer than 20 days nor more than 60 days after the passage of this Resolution.
