A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OLYMPIA, WASHINGTON, APPROVING A LOCAL AGENCY PROJECT PROSPECTUS AND LOCAL PROGRAMS STATE FUNDING AGREEMENT BETWEEN THE CITY OF OLYMPIA AND THE WASHINGTON STATE DEPARTMENT OF TRANSPORTATION FOR 2023-2025 SAFE ROUTES TO SCHOOL PROGRAM GRANT FUNDS FOR THE NW AND SW NEIGHBORHOOD BIKE BOULEVARD PROJECT

WHEREAS, the City of Olympia applied for and received \$837,900 of 2023-2025 Safe Routes to School Program grant funds (the Grand Funds) in May 2023 for design and construction of the City's NW and SW Neighborhood Bike Boulevard Project (the Project); and

WHEREAS, the Project will provide improved, safer bike facilities within the transportation network to better facilitate a wider range of cyclists, both in age and ability; the Project has a total estimated cost of \$897,000, with the City contributing \$59,100, and the remainder of the project cost, \$837,900, paid with Grand Funds; and

WHEREAS, the City must sign and submit to the Washington State Department of Transportation a Local Agency Project Prospectus and Local Programs State Funding Agreement in order to receive the Grant Funds; and

WHEREAS, per Olympia Municipal Code Section 3.16.020(C), it is necessary for the City Council to approve the Local Agency Project Prospectus and the Local Programs State Funding Agreement and authorize the City Manager to accept grant funds and sign all documents necessary to continue the Project;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL DOES HEREBY RESOLVE as follows:

- 1. The Olympia City Council hereby approves the Local Agency Project Prospectus and Local Programs State Funding Agreement between the City of Olympia and the Washington State Department of Transportation for the Grant Funds for the design and construction of the Project and the terms and conditions contained in those documents.
- 2. The City Manager is directed and authorized to execute on behalf of the City of Olympia the Local Agency Project Prospectus, Local Programs State Funding Agreement, and any other documents necessary to accept and obligate grant funding to complete the design and construction of the Project, and to make any minor modifications as may be required and are consistent with the intent of the Agreement, and to correct any scrivener's errors.
