6. STAFF ANNOUNCEMENTS & INFO REQUESTS

6.A <u>15-0090</u> Memorandum responding to Commission questions about new multi-family development.

Mr. Stamm discussed why the low impact development regulation adoption target has been moved to June 2016. He updated the Commission about a report to be given by the Land Use & Environment Committee at the next PC meeting on February 2, 2015 regarding the Downtown Strategy.

Ms. Ray answered questions about the Downtown Action Plan and discussed the new deadline set by Council for all Comprehensive Plan (CP) amendment proposals to be submitted by March 2, 2015.

Mr. Stamm discussed the multi-family housing densities memo outlining how new developments are meeting target numbers for density.

Discussion:

- Concerns about senior housing projects located too far from downtown necessitating car dependency.
- Providing a map to indicate the exact sites for senior housing projects.
- How the public will be notified about the CP deadline change.
- Potential presentation at City Council meeting regarding the new March 2, 2015 deadline.
- Difficulties of noticing public when the media does not track or report changes.

Ms. Ray discussed the City's plan for notifying Neighborhood Associations.

Mr. Stamm discussed senior housing general age restrictions and how the market, not the City, determines viable sites. He reviewed a list of new project applications.

Ms. Ray discussed the status of partner work groups, nonprofit, and government staff working on the Action Plan and outlined the sequence of PC involvement and oversight to evaluate consistency with the CP.

Discussion:

- Understanding the Action Plan work group charter.
- Adding to the PC work plan time for the draft action review.
- Proposal periods are from years 1 to 6, 6 to beyond.
- Specific outreach plans for the public engagement process including kick off, focus meetings and OLYspeaks.
- SCJ Alliance consulting firm services.
- Importance of more forums than Twitter and Facebook as part of the social media campaign.
- The intention of launching a City e-newsletter.
