He reviewed the Action Plan goals and the 5 Year Strategic Plan for CDBG funding. Mr. Bauer noted these recommendations reflect a balanced approach to housing and economic development.

He reviewed the annual program cycle and regulatory rules that must be followed.

Program Manager Anna Schlecht gave some background on the proposed projects and activities, which include a Community-Day Center, Business Training and Resiliency Program, Tune-Up Program, Downtown Safety & Facade Improvement Program, Housing Rehabilitation and Downtown Ambassador Program.

Ms. Schlecht reviewed the actions to follow:

Post the 2017 Annual Action Plan online
Hold a public hearing - June 20, 2017
Review public comment & approve final plan - July 11, 2017
Submit final CDBG Action Plan - July 15, 2017

Councilmembers asked clarifying questions and discussed the proposals.

Several Councilmembers shared they were pleased with the balance of priorities in the proposed package and range of proposals; asked for every effort to be made to leverage funds; discussed the need for a need for a low barrier shelter; highlighted it is critical to have a good neighbor policy for the proposed warming center; and noted the proposals received align well with the results of the recent citizen survey.

Mayor Selby shared concerns regarding the warming center proposal. The Mayor asked there be an emphasis on housing rehabilitation as opposed to a shelter. Councilmember Hankins noted she also shares Mayor Selby's concerns.

Councilmember Bateman moved, seconded by Councilmember Gilman, to approve the recommended activities included in the draft Program Year 2017 Community Development Block Grant Annual Action Plan and commence the public process period, from June 7 - July 7, 2017. The motion carried by the following vote:

### **Background and Analysis:**

This year marks the 18th year of the Least Cost Pavement Preservation Program for the City. The program purpose is to extend the overall life of streets. Pavement preservation methods include: crack seal, microsurfacing, and chip seal. This approach reduces the overall cost of maintaining City streets and keeps them in fair or better condition.

This project will use chip seal to improve approximately three miles of roadway throughout the City at the following locations;

- Harrison Avenue Division Street to West Bay Drive
- 14<sup>th</sup> Avenue NW Kaiser Road to Walnut Loop
- Walnut Road Walnut Loop to Division Street

Type: contract Version: 1 Status: Consent Calendar

- Cooper Point Auto Mall Drive US 101 to Black Lake Boulevard
- State Avenue\* Quince Street to Tullis Street

\*One lane of the recently paved section of State Avenue from Quince Street to Tullis Street has cracked and failed in some areas earlier than expected. We believe this occurred because the pavement is thinner in this area, developed small cracks, and rainwater penetrated the surface during our wet winter. Chip sealing the southern lane in this area should help prevent further deterioration of the pavement surface.

We anticipate starting construction in July and ending by September, 2017.

### Neighborhood/Community Interests (if known):

The community should expect delays for people driving, biking, and walking throughout the time construction is happening. The City will communicate with citizens, emergency responders, schools, Intercity Transit, and other stakeholders about the schedule and traffic impacts through Twitter, media releases, and postcards.

### **Options:**

- Award the construction contract to Doolittle Construction, in the amount of \$879,316, and authorize the City Manager to execute the contract. The project proceeds as planned.
- Reject all bids and direct staff to rebid the project. The time needed to rebid will delay
  construction until 2018. The cost may increase due to increased staff time to rebid the project.
  Further, additional pavement deterioration and preparation work may be required because of
  the delay.

### **Financial Impact:**

The 2017 Pavement Preservation Project is funded by the Street Repair/Reconstruction Program.

The low bid of \$879,316 is approximately 11.4 percent below the Engineer's estimate. There are sufficient funds in the budget to complete this project.

Contingency to Award (10%): \$87,932
Engineering: Design, Inspection, Consultants \$125,977
Total Estimated Project Cost: \$1,093,225

Total Available Project Funding: \$ 1,093,225



### **Background and Analysis:**

The Engineering Design and Development Standards (EDDS) guide the design and construction of transportation, drinking water, reclaimed water, sewer, stormwater, and solid waste collection systems. They are also the technical interpretation of the City's Comprehensive Plan and various utility master plans. The City Engineer is responsible for approving and administering the EDDS.

### The EDDS are updated annually to:

- o Implement Goals and Policies established in the City's Comprehensive Plan,
- Reflect changes to the Olympia Municipal Code (OMC), particularly Titles 12-18,
- Help implement policies established in approved Utility Master Plans,
- Address changes in equipment and materials,

- o Enable the use of improvements in technology, and
- o Clarify information and requirements described in the text and shown on standard drawings

This year's update addresses several Comprehensive Plan Policies and OMC chapters related to:

- Curb Ramps,
- Pedestrian Pathways,
- Traffic Impact Analyses, and
- Length of City Blocks

The first attachment summarizes the proposed changes, including why they are needed. The second attachment is a public communication and involvement strategy that will be used for specific topics that that may be of interest to our stakeholders. The third attachment summarizes the timeline staff follows to update the EDDS this year, including a public hearing in November and approval of the changes in December.

### Neighborhood/Community Interests (if known):

The EDDS provide predictability and consistency in how the City's infrastructure is built. Making timely changes to the EDDS ensures that infrastructure installed meets the most current standards and builds the foundation for the City's vision.

Information related to the proposed changes is available on the City webpage. Stakeholders are engaged throughout the review and approval process.

### **Options:**

- 1. Approve the recommended 2017 topics and strategies. Approval will allow staff to begin to develop the specific changes and begin communicating and getting feedback on the changes.
- 2. Do not approve the recommended 2017 topics and strategies and have staff revise as directed. Not approving delays the development of the specific changes and may impact the timeframes on the attached schedule.

### **Financial Impact:**

Most of the proposed changes should not result in notable increases to the costs of private development or public work projects. However, a few, such as pedestrian pathways and requiring curb ramp improvements on a more consistent basis, may cost more to developers and private utilities.

### 9.40.095 Graffiti

**PUBLISHED:** 

- A. A person is guilty of graffiti if, without prior consent of the owner or owner's agent, the person he or she intentionally writes, paints, or draws any inscription, figure, or mark of any type on any public or private building or other structure or any real or personal property owned by any other person.
- B. Subsection (A) of this section shall not apply to any person who has permission from the owner, operator or custodian of the property.
- BC. Graffiti is a gross misdemeanor punishable as described in OMC 9.64.010.
- **Section 2.** Corrections. The City Clerk and codifiers of this Ordinance are authorized to make necessary corrections to this Ordinance including, but not limited to, the correction of scrivener/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.
- **Section 3. Severability.** If any provision of this Ordinance or its application to any person or circumstance is held invalid, the remainder of the Ordinance or application of the provisions to other persons or circumstances shall remain unaffected.
- **Section 4.** Ratification. Any act consistent with the authority and prior to the effective date of this Ordinance is hereby ratified and affirmed.
- Section 5. Effective Date. This Ordinance shall take effect thirty (30) days after publication, as provided by law.

### NOW, THEREFORE, THE OLYMPIA CITY COUNCIL ORDAINS AS FOLLOWS:

**Section 1.** <u>Amendment of OMC 15.04.120</u>. Olympia Municipal Code 15.04.120 is hereby amended to read as follows:

### 15.04.120 Refunds

- A. If the City or District No. 111 fails to expend or encumber the impact fees within six (6) years ten (10) years of when the fees were paid, or where extraordinary or compelling reasons exist, such other time periods as established pursuant to Sections 15.04.100 or 15.04.110, the current owner of the property on which impact fees have been paid may receive a refund of such fees. In determining whether impact fees have been expended or encumbered, impact fees shall be considered expended or encumbered on a first in, first out basis.
- B. The City shall notify potential claimants by first class mail deposited with the United States Postal Service at the last known address of such claimants. The potential claimant must be the owner of the property for which the impact fee was paid.
- C. Current owner(s) seeking a refund of impact fees must submit a written request for a refund of the fees to the Director and/or District No. 111 within one (1) year of the date the right to claim the refund arises or the date that notice is given, whichever is later.
- D. Any impact fees for which no application for a refund has been made by the claimant within this one-year period shall be retained by the City or District No. 111 and expended on the appropriate public facilities. Claimants shall have no rights to a refund if not timely requested pursuant to Subsection 15.04.120(C).
- E. Refunds of impact fees under this Section shall include any interest earned on the impact fees by the City or District No. 111.

- F. When the City seeks to terminate any or all components of the impact fee program, all unexpended or unencumbered funds from any terminated component or components, including interest earned, shall be refunded pursuant to this Section. Upon the finding that any or all fee requirements are to be terminated, the City shall place notice of such termination and the availability of refunds in a newspaper of general circulation at least two (2) times and shall notify all potential claimants by first class mail at the last known address of the claimants. All funds available for refund shall be retained for a period of one (1) year. At the end of one (1) year, any remaining funds shall be retained by the City, but must be expended for the appropriate public facilities. This notice requirement shall not apply if there are no unexpended or unencumbered balances within the account or accounts being terminated.
- The City shall also refund to the current owner of property for which impact fees have been paid all impact fees paid, including interest earned on the impact fees, if the development activity for which the impact fees were imposed did not occur; provided that, if the City or District No. 111 has expended or encumbered the impact fees in good faith prior to the application for a refund, the Director or District No. 111 can decline to provide the refund. If within a period of three (3) years, the same or subsequent owner of the property proceeds with the same or substantially similar development activity, the owner can petition the Director or District No. 111 for an offset against the actual impact fee amounts paid. The petitioner must provide receipts of impact fees previously paid for a development of the same or substantially similar nature on the same property or some portion thereof. In the case of park or transportation impact fees, the Director shall determine whether to grant an offset, and the determinations of the Director may be appealed pursuant to the procedures in OMC Chapter 18.75. In the case of school impact fees, District No. 111 shall determine whether to grant an offset. District No. 111 shall forward its determination to the Director, and the Director may adopt the determination of District No. 111 and may grant or decline to grant an offset, or the Director may make an alternative determination and set forth the rationale for the alternative determination. Determinations of the Director shall be in writing and shall be subject to the appeals procedures set forth in OMC Chapter 18.75.
- **Section 2.** <u>Severability</u>. If any provision of this Ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or application of the provisions to other persons or circumstances shall remain unaffected.

**Section 3.** Ratification. Any act consistent with the authority and prior to the effective date of this Ordinance is hereby ratified and affirmed.

**Section 4.** <u>Effective Date</u>. This Ordinance shall take effect five (5) days after publication, as provided by law.
