5. BUSINESS ITEMS

5.A <u>21-0730</u> Discuss Salary Compensation Research

The Salary Commission came to a preliminary consensus that they want to recommending that Council receive a 3.09% COLA salary increase. This is the COLA amount Independent City staff received since Council salaries have been evaluated (2.07% increase in 2020 and 1% in 2021) plus interest.

The Commission also discussed health insurance benefit stipends. The group came to a preliminary consensus that they want to recommend an increase commiserate to the City-paid portion of staff premiums. They also want to increase the dental benefit to have Council's dental premiums 100% covered and want to add vision coverage with 100%

premium costs covered by the City.

The group also researched health plans on the market to see what a plan comparable to the city plan costs and the lowest deductible offered on WAHealthPlanFinder.org is twice that of the city plan and the lowest out-of-pocket max is \$2,000 more than what is offered by the City. They want to recommend adding half the cost of the out-of-pocket max difference (additional \$1,000 per Councilmember).

The Commission will have a meeting on Monday, July 26 at 5:30 pm to finalize their recommendation.
