Background and Analysis:

Introduction

20 people submitted applications to fill the five upcoming vacancies on the BPAC. At the November meeting, the BPAC decided that each Committee Member would review and rank the applications ahead of the meeting. Each member has submitted the results of their evaluation to the staff liaison. Those results are attached.

Scoring and ranking process

The scores and rankings are meant to be a guide for the meeting's discussion. The candidates who are currently scored the highest may not be the candidates the BPAC recommends to the City Council for appointment.

The scores were based on criteria that the BPAC decided at the November meeting. They are:

- Unique perspective
- Engagement in walking, biking, and transit
- Interest in community involvement

Committee Members scored the candidates on a scale of 1 to 5 in each of those categories.

Additionally, Committee Members considered a general idea of where each candidate lives in order to have fairly even geographic representation. For example, the staff liaison included a note such as “northeast” or “downtown” for each candidate in the evaluation sheet emailed to Committee Members.

Next steps

After the BPAC recommends five people to fill the upcoming vacancies, that recommendation will be shared with the Community Livability and Public Safety Committee, a subcommittee of the City Council. CLPS will likely consider the recommendation and then make its own recommendation to the full City Council in time for the new Members’ terms to begin on April 1st.

All of the candidates will be invited to attend this meeting virtually and may be listening in to the Committee’s discussion. They will not be asked to address the BPAC.

Climate Analysis:

This is routine Committee business that will not directly impact the City’s work around climate change. However, the BPAC’s work is focused on developing policy to make it easier to walk or bike in Olympia, which has the potential to reduce greenhouse gas emissions by replacing drive-alone trips by walking or biking.

Equity Analysis:

The City does not collect demographic information on applicants. Since names and addresses can often indicate race, ethnicity, gender, or class, we have redacted them from the applications being reviewed. We have also done that out of respect for the applicants’ privacy.

Options:

1. Option 1: recommend five candidates to fill the upcoming vacancies. The Committee may also wish to choose some alternates.
2. Option 2: not recommend candidates to fill the upcoming vacancies. This will require that the Community Livability and Public Safety Committee evaluate all 20 of the applicants without the benefit of the BPAC’s input.

There is no financial impact from this item.

I am a retired 19-year resident of the Indian Cr. area who has worked tirelessly with city officials and neighbors to protect and enhance the surrounding area for pedestrians and bicyclists and for future Olympia residents. I was very involved with the OPARD leadership a number of years ago during the city acquisition of the properties along the Karen Fraser Woodland Trail and donated land to the city during that process. I have worked, and continue to work to ensure bike routes are protected and maintained and because I walk approximately 3000 miles a year around the city on trails and through our many wonderful parks, I have a deep understanding of the great park system and the threats that our parks and trails face in the future. It would be a great privilege to serve on either of these committees as a voice to continue to support pedestrian access for all user groups and the continued maintenance and possible growth of our superior parks system.

Describe your experience, qualifications, and/or skills which would benefit the advisory committee(s) you are applying to.

My education and professional experience includes a degree in botany/plant ecology plus a number of years of graduate work, plus many years in the field of land surveying, with numerous years in a research setting assessing botanical and mycological conditions in managed forests. As such I have extensive knowledge about plant succession, invasive plant management, and more, while also having significant knowledge about land management generally. As one who now walks more than I drive, I also have extensive understanding about the challenges faced by pedestrians and bicyclists.

As a former member of a U.S. Forest Service research team with numerous peer-reviewed journal articles of which I was co-author, I have the skills needed to review, understand, and critique scientific and technical material. As an Admin. Assistant later in my career, I also have the skills to facilitate and organize meetings and to provide meeting notes, summaries of meetings, etc. while being skilled in the use of Office programs, including spreadsheets and PowerPoint and Word among many others. I have facility in a great deal of other computer applications.

Share the ways you've been involved or have volunteered in the community.

Since moving to my current home in February 2004, I have been very involved in the improvement of the Woodland Trail in many ways. In the early years, I assisted other Indian Cr. neighbors in cleaning up the numerous camps that littered the trail corridor. Later, I met with Paul Simmons and lent support to the idea of the city consolidating ownership along the trail and was involved in both suggesting that the city initiate a conversation with Thurston County in regard to acquiring the county-owned land (which they did) and also in being a significant part of further consolidation by donating approximately 2 acres to the city.

Later, I worked actively and successfully with John Lindsey (traffic data coordinator for Olympia Public Works) to have "No Parking" signage placed along the Wheeler Bike Route. As one who walks all or part of this route daily, this was a huge improvement for me and the other bicyclists and pedestrians who use this route.

I have on many occasions independently volunteered to pick up trash along Central S.E. and along Wheeler, and cleaned up an enormous amount of trash in Indian Cr. south of Wheeler a few months ago.

I have, on a number of occasions, contacted OPARD staff about campers or debris or fallen trees that I find in the parks or along the bike paths, and have a very good relationship with the Park Rangers who have been so instrumental in minimizing the camping along the Woodland Trail.

Perhaps no one in Olympia walks more than I do! I walk 8 - 10 miles per day throughout the year on trails, sidewalks, through the parks, across the Capitol campus, etc., etc. On more than one occasion, I have walked 15 miles in a day and gone through or near 10 or more parks in Olympia and Tumwater, plus the Capitol campus. In some years I have bicycled more than other years, and when I do, I ride the Woodland Trail and/or Chehalis Western Trail either to Woodard Bay or south to Rainier, Tenino or Yelm.

Yes, I absolutely do have a unique perspective. As I said above, perhaps no one in Olympia walks more than I do around our towns. As such, I get to see both the many great things about our highly walkable city, as well as some of the challenges that we all face, including scattered campsites, vandalism, and litter of all kinds, to say nothing of maintaining a safe pedestrian environment for folks of all ages.

My volunteer work is as discussed above where I said how I'd been involved with or volunteered in my community – mostly independent of organized groups.

My current efforts are directed towards communicating my concerns about the issues that continue to proliferate along the Wheeler Bike Route.

As stated above, I walk and occasionally bike, in parks around Olympia on a daily basis. Our parks and trails are a huge part of what makes Olympia so special, and I'm extremely proud of having been part of the land donation process that resulted in consolidation of ownership along the Woodland Trail by the city. I am pleased that the city purchased the old armory and to see that it will be an incredible addition to parks and recreation in Olympia.

I have little to say here, but having led and taught field trips and classes about plant identification (my forte!) in the past, I'd be happy to do so again.

I am currently a board member and treasurer of Club Oly Road Runners(CORR), a local running group and chapter of the Road Runners Clubs of America. We have board meetings monthly, with runs 5 days a week. Last year I ran 1839 miles, and this year so far I have run 1523 miles. I sometimes bike as well, but often my local errands are via running but occasionally biking as well. I now also take my daughter around in a stroller, soon to be a run stroller.

Question Applies to the Bicycle and Pedestrian Advisory Committee: Do you have a unique perspective on walking and biking? If so, please explain.

One unique perspective I feel I bring is that while on foot (running) I was struck by a vehicle traveling between 30-40 MPH. On a July morning in the summer of 2011, I went for a run. I was hit and then flipped over a car going 35-40 miles per hour. The trauma of a 150 lb human against a 4000 lb vehicle is survivable and recoverable if you land luckily. I was young, in good physical and mental shape, with excellent health insurance, and a wonderful support network. I was in the ICU for 3 weeks at Johns Hopkins Hospital, having surgery after surgery replacing the shattered bones in my lower left leg with a titanium composite, rebuilt my shoulder with smaller pieces of metal, and watched my spine carefully as I had fused some of the bones together. The orthopedic surgeons did excellent work and after another 4 weeks in an in-patient rehabilitation I could walk and then nine months later I could run again. I can now run without any problems, but am always cautious when running along the road. I feel that is a rather rare perspective to bring.

Briefly describe why you wish to serve on this/these Advisory Committee(s).

I believe that the degree of car dependency we have in Olympia (and North America generally), harms the health, equity, and finances of our community. The work of improving bicycling, walking, rolling, and transit is essential to making sure that this is a place where our diverse population can thrive. I hope that by joining the Bicycle and Pedestrian Advisory Committee I can be more involved in my community and use that involvement to help create a future where Olympia is not only resilient in the face of coming challenges but meets those challenges proactively.

Describe your experience, qualifications, and/or skills which would benefit the advisory committee(s) you are applying to.

For the past 25 years I have been a bicycle commuter, pedestrian, and transit rider in a variety of environments, ranging from Anchorage to San Francisco to Olympia, and have also been a driver. I believe that this breadth of experience helps me to look at issues from multiple perspectives, and has taught me not only the value of compromise but also that transportation is not a zero-sum game, what's good for non-drivers is also good for drivers.

In addition, I spent 10 years working at the Olympia Timberland Library, where I worked closely with people from all walks of life and was able to see many of the transportation-related struggles that affect both disadvantaged and relatively affluent segments of our community. I believe this experience helps me to empathize with people who have fewer transportation options than I do.

I have developed a skillset around reading proposed policies and thinking out the direct and indirect consequences of them, and have also directly experienced how difficult it is to predict second-order effects of even small policy changes. I have not been as involved with the community as I would have liked for the past few years, and part of my motivation for wanting to join the committee is as a way of becoming more active again. That being said, prior to the pandemic I volunteered at my kid's school, organized a team to participate in the Bicycle Community Challenge (starting back when the event had a registration fee and teams were a bit more formal), helped to organize the 2018 South Sound Board Game Convention, participated in public meetings, and corresponded with my elected representatives.

Currently I work for the WA Department of Transportation as a Management Analyst, with a focus on coordinating procedure and policy for a large and complex project. Prior to that, I worked at the Olympia Timberland Library for 10 years, starting as a Library Aide and ending as the Operations Supervisor for the branch. In college, I studied Philosophy. Through these experiences, I have developed skills in finding the merits of multiple, seemingly-contradicting, viewpoints and finding solutions that meet the requirements of as many stakeholders as possible.

I can commit to 10 hours per month on a regular basis, but am flexible and would be able to occasionally do more if the need arises.

Question Applies to the Bicycle and Pedestrian Advisory Committee: Describe your participation with walking and biking in Olympia.

Biking has been my preferred mode of transportation since I moved here in 2008. Much of my biking has been on my commutes, which have taken me all over the Olympia-Lacey-Tumwater area on routes with infrastructure that ranged from nonexistent to the Chehalis Western and Woodland trails. In addition, I try to make as many trips as possible on a bike, from picking up groceries to going out to restaurants to doctor's appointments. When my kid was small I towed him all over in a bike trailer and now ride with him to school, which has given me a whole different perspective on the necessity of bicycle infrastructure.

Prior to the pandemic, when I worked downtown I enjoyed exploring the city on foot and have walked through most of downtown and much of the east and west sides as well. I believe that the best way to get to know a place is to experience it on foot and so take the opportunity to walk places whenever possible.

Question Applies to the Bicycle and Pedestrian Advisory Committee: Do you have a unique perspective on walking and biking? If so, please explain.

What might give me a different perspective from most is that I have walked and cycled extensively in other cities. Growing up in Anchorage I got around mostly by bicycle, walking, and public transportation. I know what it's like to walk a mile over unplowed sidewalks piled high with snow and grit from the roads, and also the joy of riding all over Anchorage's extensive trail network on long summer days. I also spent several years in San Francisco, where I did not own a car and walked, biked,

or took the bus/BART everywhere. During those years, the city had many cyclists but little dedicated bicycle infrastructure beyond painted bike lanes and I learned that taking side streets was often safer than using a bike lane and that the biggest safety benefits seemed to come from drivers expecting to see bicyclists, and so not being surprised and unprepared when sharing the road.

However, the biggest thing that has informed my perspective on walking and biking has been riding with my 10 year old. Many of the routes that I had taken regularly in the past no longer feel safe now that I am traveling with an inexperienced rider. This shift in perspective has made me keenly aware of the importance of separated infrastructure. I have had similar experiences walking with my kid, and am now constantly notice places that lack sidewalks. I believe that this perspective, lots of experience with commuting by foot and bicycle but also a keen understanding of the needs of people who have a healthier level of risk tolerance, makes me a good candidate to help advise the City in ways to be more inclusive to those outside of cars.

Although I have volunteered quite a bit, most of it was prior to moving to Olympia. The only volunteer work that I have done here has been helping out in my kid's classroom and organizing a board game convention in 2018.



Background and Analysis:

Process

Each year, Olympia advisory committees submit draft work plans to the City Council's Community Livability and Public Safety Committee. After reviewing the work plans, CLPS makes a recommendation to the City Council on whether to accept them. Advisory committee work plans run from April 2023 to March 2024.

Work Plan

The draft work plan includes:

- Reviewing proposed changes to the Engineering Development & Design Standards.
- Providing feedback about the upcoming Comprehensive Plan update
- Briefings about the Capital Mall Triangle project, progress in implementing the ADA Transition Plan, an update to the Street Safety Plan, and grants the City is pursuing.

These are all in addition to the committee's annual review of the *Capital Facilities Plan*.

The BPAC work plan interfaces with City staff's work plan. Staff can support six BPAC meetings in the calendar year of 2023.

Climate Analysis:

The BPAC's participation in several of the items on this work plan will help make Olympia easier to walk and bike in. This has the potential to reduce greenhouse gas emissions in the transportation sector.

Equity Analysis:

Making the city easier for people to walk and bike in can make it more feasible for people to get around without a car. Car ownership is costly and not everyone is able to drive.

Options:

Option 2: Change the draft work plan, accept it, and refer it to the City Council

Every member has an equal voice.

The group is the final authority.

Discussions

- ◆ No one speaks twice until everyone has had a chance to speak once
- ◆ Members must be recognized by the chair before speaking
- ◆ Members address the chair, not each other
- ◆ Members may address presenters directly once recognized by the chair

Motions

- ◆ Anyone can make a motion at any time after the chair has recognized them to speak
 - ~ *Chair repeats the motion*
- ◆ Anyone can second the motion—don't need to wait for chair's recognition
 - ~ *If there is no second, the motion doesn't proceed*
- ◆ Motion gets discussed, if needed
- ◆ Motion can be amended
 - ~ *Members discuss and vote on any amendments*
 - ~ *Chair repeats motion as amended*

Voting

- ◆ When discussion wanes
- ◆ Chair clearly states motion (as amended, if it was)
- ◆ Vote
 - ~ *"All in favor, say aye"*
 - ~ *"All opposed, say no"*
- ◆ Chair states results of vote
 - ~ *"The ayes have it and the motion passes"*
 - ~ *"The noes have it and the motion fails"*
