#### **Background and Analysis:**

In March 2009, the City Council approved a resolution allowing City staff to use the U.S. Communities Cooperative Purchasing Alliance (Alliance) to acquire goods and services. We accessed the Alliance to purchase cubicles for the new City Hall and to reroof three City-owned buildings. City Council approved staff to use the Alliance through March 31, 2011. This approval has since expired. To access the Alliance services, a new resolution from City Council is required.

The Alliance was formed in cooperation with an advisory board of local and state government officials and jointly sponsored by the National Association of Governmental Counties, the National Institute of Governmental Purchasing, the National League of Cities, and the United States Conference of Mayors. The Alliance pools the purchasing power of public agencies nationwide to achieve the most

favorable pricing for local agencies.

The Alliance offers the following advantages:

#### 1. Savings:

- The most favorable government pricing, exceeding the savings available through state contracts.
- Offers up to 60% off retail pricing with no user fees.
- Combines the potential purchasing power of up to 87,000 local agencies.
- 2. Competitively solicited with oversight: An advisory board guides the program direction and selects high quality products; all contracts are competitively solicited and meet government contract requirements.
- **3. Wide range of products**: the Alliance offers products useful to the City of Olympia, ranging from office supplies, to playground equipment to roofing materials.
- **4. Approved for use in the State of Washington**: On March 26, 2004, Governor Gary Locke signed House Bill 2615 modifying the Washington Interlocal Cooperation Act, which stated that U.S. Communities contracts are available to all Washington local public agencies without any further solicitation process.

#### **Background and Analysis:**

In 2014, the Wildwood Neighborhood Association and Governor Stevens Neighborhood Association submitted a joint proposal under the City of Olympia's Neighborhood Pathways Program to formalize the pathway running from the dead end of Moore Street SE to O'Farrell Ave SE. The pathway has existed for many years on private property. While all the affected property owners have allowed the pathway to exist on their property, both neighborhood associations were concerned that future property owners might choose to block access to it. Therefore, the acquisition of easements to ensure this pathway's continued existence was a key part of the neighborhoods' proposal.

Through the easement acquisition process, we discovered that the driveway running north from the dead end of Moore Street is located on the City's Trillium Park property. The driveway is the access for three homes and a City water main runs underneath it. The water main serves those same

homes. The three homes and City water main are not within an easement over the Trillium Park property. Technically, the homeowners and City maintenance staff do not have legal access to the homes or water main. The solution to provide legal access to the three homes and continued maintenance of the water main is to dedicate the driveway area over a portion of the Trillium Park property as public right-of-way.

Based on City and County records, the driveway and water main have been in place since the mid-1950s. Staff believes that the location of the driveway and water main, in relation to the Trillium Park property, were unclear at the time the Park was deeded to the City. Given the existing conditions and adjacent owner's long time use, it is in the best interest of all parties to dedicate this portion of Trillium Park property as public right-of-way.

Four property owners granted the Trillium Park property (Lots 19G, 23 and 23B, Replat of Bates Extension) to the City for Park purposes with restrictions of use in October, 1989. Due to the deed restrictions in place, the City is unable to dedicate a portion of the property for right-of-way purposes.

In order for the City to move forward with right-of-way dedication, an Acknowledgement of Release of Deed Restrictions had to be signed by all of the parties that created the deed restrictions. The restrictions will only be released over the existing driveway location and water main location. Staff has worked with the owners that created the restrictions and the Acknowledgement of Release of Deed Restrictions have been fully executed by all parties and recorded.

#### Neighborhood/Community Interests (if known):

The right-of-way dedication will provide legal access for the adjacent property owners, the public using the Moore Street Pathway and City maintenance staff.

#### **Options:**

- 1. Approve the right-of-way dedication to extend Moore Street, and authorize the City Manager to execute all necessary right-of-way dedication documents.
  - a. Provides legal access for adjacent property owners, the public and City maintenance staff.
  - b. Is consistent with City standards and the Neighborhood Pathway Program.
- 2. Do not approve the acquisition of easements.
  - Adjacent property owners will not have legal access across the Trillium Park to their property.
  - b. Could affect the neighborhoods ability to use the pathway in the future.

#### **Background and Analysis:**

The City of Olympia's Storm and Surface Water Utility has provided support to South Sound GREEN since its inception in 1992.

South Sound GREEN provides environmental education for grade school, middle, and high school students. They study local watershed issues, perform water quality monitoring and host the annual Student GREEN Congress. Every year over 1,200 students participate in South Sound GREEN.

The South Sound GREEN program relies on outside funding (both public and private) and is a great example of leveraging funds from many different sources. The current South Sound GREEN

intergovernmental contract between Olympia, Lacey, Tumwater, Thurston County, and Thurston Conservation District expires on December 31, 2015.

Continuing the provided services requires a new agreement.

## Neighborhood/Community Interests (if known):

South Sound GREEN is highly regarded by the community and Olympia schools.

## **Options:**

1. Approve the proposed intergovernmental agreement with the Thurston Conservation District for the 2016-2020 South Sound GREEN program.

## **Implications:**

- a) The City of Olympia's Storm and Surface Water Utility will provide funding at the requested level (\$14,400/annually).
- b) City of Olympia students continue to participate in water quality monitoring and watershed education as provided by South Sound GREEN.
- c) City staff continues to participate on the South Sound GREEN Advisory Committee.
- Fund South Sound GREEN at a reduced level.

#### Implications:

- a) Program service level in Olympia would decrease.
- b) Regional cohesiveness and support for the program may be disrupted.
- 3. Discontinue all funding.

#### **Financial Impact:**

The Thurston County Conservation District requests \$14,400/year from the City of Olympia's Storm and Surface Water Utility. This is an increase from the current agreement of \$12,000/year. The Storm and Surface Water Utility has budgeted the necessary funding.

## INTERGOVERNMENTAL SERVICES CONTRACT FOR SOUTH SOUND GREEN BETWEEN

## THE CITIES OF LACEY, OLYMPIA, TUMWATER, AND THURSTON COUNTY AND THE THURSTON CONSERVATION DISTRICT

THIS CONTRACT, pursuant to chapter 39.34 RCW, is made and entered into in five duplicate originals by and between the Cities of Lacey, Olympia, Tumwater, and Thurston County, hereinafter "LOCAL JURISDICTIONS" and THURSTON CONSERVATION DISTRICT, hereinafter "DISTRICT". Wherein the DISTRICT administers a watershed education program for grades 4-12 known as South Sound GREEN (SSG) the LOCAL JURISDICTIONS enter into this contract.

In consideration of the mutual benefits and covenants contained herein, the parties agree as follows:

#### 1. PURPOSE OF CONTRACT

The LOCAL JURISDICTIONS have storm and surface water utilities with a regulatory responsibility to provide education to the general public, including school aged children, on the impacts of stormwater on surface waters and to provide opportunities to become involved in stewardship activities. In addition, the Local Jurisdictions have determined that providing storm water and watershed-education through local partnerships offers a cost effective method to deliver required educational messages. The Local Jurisdictions enter into this contract with the DISTRICT because it has a proven record of administering an effective watershed-education program for grades 4-12 known as South Sound GREEN (SSG).

#### 2. SERVICES PROVIDED BY THE CONTRACTOR

The DISTRICT represents that it is qualified and possesses the necessary expertise, knowledge, training, skills, and the necessary licenses and/or certifications to perform the services set forth in this Contract. The DISTRICT through the SSG program shall perform the following program activities and services designed to reduce or eliminate behaviors and practices that contribute to adverse stormwater impacts:

- a. Provide overall program coordination including two annual teacher watershed education networking meetings; provide classroom presentations on topics such as watersheds, water quality, and nonpoint pollution prevention; coordination with community water resources-related stewardship projects; coordination with school districts, agencies, and community groups to ensure good communication about SSG's educational programs, opportunities and activities, and to ensure school as well as community participation in activities listed below in items b. j.
- b. Provide support and training for two water quality monitoring days (i.e., fall and winter) for approximately 1000 students, teachers, and volunteers. Support includes monitoring equipment, transportation for students, substitute teacher reimbursements, and lab fees.
- c. Organize and carryout a Student GREEN Congress in the spring for approximately 400 students. Activities shall include opportunities for water quality data analysis, water resources-

related problem solving and stewardship, learning and applying new environmental education skills, and celebrating accomplishments. Support will include performance of all things necessary to hold the Student GREEN Congress including but not limited to providing associated materials and supplies, paying facility rental fees and transportation costs, and providing substitute teacher reimbursements.

- d. Provide an annual Summer Teacher Watershed Training Institute to present new information on watershed, stormwater, and water quality issues; meet with teachers to evaluate watershed, stormwater, and water quality education program results; and to recruit new teachers to SSG via the Summer Teacher Training Institute; including a component specifically targeted at new teachers. Support includes curriculum materials, speaker stipends, refreshments, and teacher stipends.
- e. Provide three Water Quality Monitoring Teacher Training workshops (i.e., September, October, February) to provide: 1) Quality Assurance/Quality Control training; and 2) Updated background information and emerging issues on the Deschutes, Totten, Eld, Henderson Inlet and other local watersheds. Support will include facility rental costs, water quality monitoring equipment, curriculum, and teacher refreshments.
- f. Evaluate the effectiveness of the program through student pre and post surveys that includes information on targeted behavior changes.
- g. Provide labor and materials. Unless otherwise provided for in the Contract, no material, labor, or facilities will be furnished by the LOCAL JURISDICTIONS.
- h. Perform according to standard industry practice of the work specified by this Contract.
- i. Complete its work in a timely manner and in accordance with the schedule agreed to by the parties.
- j. The DISTRICT will submit billing invoices along with companion narrative progress reports to each jurisdiction on a quarterly basis within two weeks of the end of each calendar quarter. Quarterly narrative progress reports shall be provided to each jurisdiction in a format that is determined by and acceptable to the respective jurisdiction. In addition to the narrative, the 4th quarter report shall include the cumulative year-end numbers of participants.

#### 4. BASE ANNUAL FUNDING

a. In consideration for the services described, the LOCAL JURISDICTIONS shall provide funding to the DISTRICT, in the amounts shown below, except in the event of a non-appropriation of funds.

City of Lacey:

\$14,400

City of Olympia:

\$14,400

City of Tumwater:

\$ 5,000 (year-one, increasing to \$6,000 in years 2 -5)

Thurston County:

\$14,400

b. Payment to the DISTRICT by each jurisdiction shall be on a quarterly basis, with 25 percent of each jurisdiction's annual payment being paid each quarter. Payment shall be made to the DISTRICT following receipt by each jurisdiction, of the DISTRICT'S invoice summarizing services rendered to date under this Contract. The DISTRICT will work with each LOCAL JURISDICTION to determine preferred report content and format.

## 5. NON-APPROPRIATION OF FUNDS

Should a LOCAL JURISDICTION fail to secure the base funding amount specified in Section 4 due to non-appropriation of funds, the LOCAL JURISDICTION shall provide written notice to the other LOCAL JURISDICTIONS and the DISTRICT within thirty (30) calendar days of its budget adoption. The LOCAL JURISDICTIONS and the DISTRICT agree to meet within fourteen (14) calendar days thereafter to discuss the impacts of such a budget non-appropriate or reduction. The LOCAL JURISDICTIONS either separately or collectively may elect to redistribute costs or eliminate DISTRICT services at their discretion.

#### 6. EFFECTIVE DATE; DURATION OF CONTRACT

The term of this Contract shall commence upon the approval of the LOCAL JURIDICTIONS' respective governing bodies and the DISTRICT, and following posting on the DISTRICT's public website. This Contract will continue in effect until December 31, 2020. By this Contract, the parties ratify performance described in this Contract that was performed between January 1, 2016 and execution of this Contract by all parties.

#### 7. HOLD HARMLESS AND INDEMNIFICATION

The DISTRICT agrees to indemnify, defend, and hold harmless LOCAL JURISDICTIONS, their elected officials, employees, and agents from and against any and all liabilities, losses, damages, expenses, actions, and claims, including reasonable attorneys' fees, arising out of or in connection with the DISTRICT'S performance of this Contract except for any damages arising out of bodily injury to persons or damage to property arising from the sole negligence of the LOCAL JURISDICTIONS, their agents or employees.

It is further specifically and expressly understood that the indemnification provided herein constitutes the DISTRICT's waiver of immunity under Industrial Insurance, Title 51 RCW, solely for the purposes of this indemnification. This waiver has been mutually negotiated by the parties. The provisions of this section shall survive the expiration or termination of this Agreement.

#### 8. CONTRACT REPRESENTATIVES; NOTICE

Each party to this Contract shall have a representative. The LOCAL JURISDICTIONS' representatives shall serve on the South Sound Green Advisory Committee and, by July of each year, will advise the committee as to the proposed amount each jurisdiction will contribute. Each representative shall serve as the contract administrator for his or her jurisdiction, for purposes of this Contract. Notice required under this Contract shall be sent to the address designated for the parties, below. Contract representatives

may be changed upon notice to the other parties. Notice will be deemed to be received three business days following deposit in the U.S. Mail, postage prepaid.

#### 9. TERMINATION AND MODIFICATION

Any party may terminate participation in this Contract by giving 30 days' written notice of intent to terminate to the other parties, provided that LOCAL JURISDICTIONS shall be obligated to pay the quarterly invoice for the quarter in which the LOCAL JURISDICTION terminates. This Contract may only be modified by agreement of all the parties hereto, executed in writing, in the same manner as this Agreement.

#### 10. JURISDICTION AND VENUE

This Contract has been and shall be construed as having been made and delivered within the State of Washington, and it is agreed by each party hereto that this Contract shall be governed by the laws of the

State of Washington, both as to interpretation and performance. Any action of law, suit in equity, or judicial proceeding for the enforcement of this Contract or any provisions thereof, shall be instituted only in any of the courts of competent jurisdiction in Thurston County, Washington.

#### 11. SEVERABILITY

- a. If, for any reason, any part, term or provision of this Contract is held by a court of competent jurisdiction to be illegal, void or unenforceable, the validity of the remaining provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Contract did not contain the particular provision held to be invalid.
- b. If it should appear that any provision hereof is in conflict with any statutory provision of the State of Washington, said provision which may conflict therewith shall be deemed inoperative and null and void insofar as it may be in conflict therewith.

#### 12. ENTIRE AGREEMENT

The parties agree that this Contract is the complete expression of the terms hereto and any oral representations or understandings not incorporated herein are excluded. Further, any modification of this Contract shall be in writing and signed by all parties. Failure to comply with any of the provisions stated herein shall constitute material breach of contract and cause for termination. It is also agreed by the parties that the forgiveness of the nonperformance of any provision of this Contract does not constitute a waiver of the provisions of this Agreement.

## 13. RECORDATION.

Per RCW 39.34.040, this agreement shall be posted and electronically available to the public on the DISTRICT's website.

#### 14. PROPERTY.

No real or personal property is to be jointly acquired, held, or disposed under this agreement.

#### **Background and Analysis:**

Senior Services for South Sound has leased space at The Olympia Center since the building opened in 1987. This lease is consistent with agreements from previous years. Senior Services for South Sound has reviewed and approved the attached contract.

Senior Services for South Sound coordinates regional services for seniors in Thurston and Mason Counties. Their lease at The Olympia Center includes regional office space as well as programming and office space necessary for the local operations of the Olympia Senior Center.

#### Lease Terms -

- Length: Calendar year 2016.
- Space: Office, lobby, reception, kitchen, storage and work space at The Olympia Center.
- Lease Payment: \$6,680.13 per quarter, plus an additional charge for extra hours of

program/special event space use above the hours detailed in the agreement.

- Utilities: City provides all utilities except telephones.
- Janitorial Service: Olympia provides janitorial and facility maintenance services; except that the Senior Services is responsible for any repairs or alterations that they cause, except for ordinary wear and tear.

## Neighborhood/Community Interests (if known):

None known

## **Options:**

Option 1: Authorize the City Manager to sign the 2016 lease. Implications:

1. Continues partnership between City and Senior Services for South Sound.

Option 2: Require staff to amend proposed contract with Senior Services for South Sound. Implications:

1. Requires reopening of negotiations with Senior Services for South Sound.

## **Financial Impact:**

No impact on expense budget. Meets budgeted revenues forecast for leases at The Olympia Center in 2016.



THIS LEASE AGREEMENT is made and entered into between the City of Olympia, herein referred to as "OLYMPIA" and SENIOR SERVICES FOR SOUTH SOUND, a Washington nonprofit corporation, herein referred to as "USER."

- 1. <u>Premises.</u> In consideration of the covenants and agreements hereinafter set forth and other good and valuable consideration, OLYMPIA hereby leases to USER a portion of The Olympia Center, herein referred to as the CENTER, located at 222 Columbia St NW, Olympia, Washington. More specifically, said portion is described generally as follows (and in detail on the attached "Exhibit A," which is hereby incorporated by reference as though fully set forth herein):
  - a.) OLYMPIA agrees to grant the USER exclusive use of the following areas:

## Dedicated Space

Office, reception, storage and work space for Senior Services for South Sound, Information & Assistance, Health and Hygiene, and Senior Nutrition Program, and the Senior Boutique.

In 2015, the Service to At Risk Seniors Program (STARS) was eliminated due to funding shortages. This space will be converted to a Health and Hygiene program with the understanding that should the STARS program be reinstated the Health and Hygiene room would be converted back to STARS. Primary programming purposes for the Health and Hygiene Room will be: health consultations, medical checks, therapeutic programs for individuals, inclusion programming for seniors with developmental disabilities, personal hygiene procedures and consultations.

#### Lobby Space

The South Lobby is for the exclusive use of the USER during all building hours as established by OLYMPIA.

USER shall be responsible for providing access to their staff and any third party individuals or organizations and provide appropriate supervision during the use. USER will not provide CENTER keys or access codes to volunteers without written agreement by OLYMPIA. OLYMPIA will not be responsible for providing access to any exclusive use areas for third party individuals or organizations.

b.) OLYMPIA agrees to grant the USER <u>nonexclusive use</u> of the following areas based upon the agreed upon hours of use by the USER. Costs associated with this use are provided for in USER's rent obligation.

Additional use beyond these hours will be charged 200% of the senior rate once hours have been exceeded for each space type.



## Programming Space (Nonexclusive)

Various program spaces as agreed to between OLYMPIA and USER. The breakdown of program space is:

- Class/meeting rooms 2250 hours
- Multi-Purpose room "A" 1190 hours
- Gymnasium 450 hours
- Special Events 120 hours in various rooms.

All "early open" (before 8am) or "late close" (after 10pm) hours will be charged to USER using the standard hourly rate for those hours. USER will communicate anticipated extra hours in advance to allow OLYMPIA to appropriately schedule staff when necessary. Thirty (30) days advance notice is preferable, but not required.

## Kitchen Space (Nonexclusive)

The Main Kitchen will be managed cooperatively by OLYMPIA and USER. Responsibilities will be as follows:

#### **OLYMPIA**

- All scheduling of facility
- Coffee service scheduling and fee collection
- Equipment repair and replacement
- Supervision of community use, except Senior Services

#### **USER**

- Provide coffee service as scheduled.
- Daily cleaning and general upkeep
- Maintain inventory of utensils, plates, cups, mugs, and other specific items as necessary.
- Training for community users (Senior Services staff can establish a schedule for training that does not conflict with nutrition operations).

At the end of the regular nutrition program (2pm, Mon-Fri), all appliances and dishes (i.e. coffee cups) will be clean and ready for community use. Any hours, including but not limited to stocking, appliance use, cleaning, or prep work requiring extra time shall be booked through OLYMPIA to avoid conflicts with community users.

In 2010, USER accepted donation of a new walk-in freezer. In order to accept this donation, space was converted to accommodate the equipment. OLYMPIA agreed to allow USER to modify the mutually agreed upon space on the condition that when the USER vacates the premises, the freezer will be removed and USER will convert such space back to its original purpose (sink and prep space).



- c.) USER is authorized to permit third party individuals and organizations access to exclusive use areas provided that the primary purpose of the third party is to promote or support senior interests in the Olympia community. Use of programming space by a group under the co-sponsorship of the USER that generates money will be charged 400% of the senior rate).
- 2. <u>Term of Lease</u>. This lease shall commence <u>January 1, 2016</u>, and shall terminate on <u>December 31, 2016</u>.
- 3. <u>Rent.</u> USER agrees to pay OLYMPIA a total of \$6,680.13 per quarter, as rental payment hereunder, for an annual total of \$26,720.52. One quarter of said annual total shall be due and payable within 30 days of the end of each quarter during the term of said lease. Payment shall be made payable to the City of Olympia and provided to the CENTER Manager.
- 4. <u>Annual Report</u>. USER agrees to provide OLYMPIA with a written annual report summarizing participation, activity and the financial status of the organization. This report will be submitted by May 1 following each calendar year.
- 5. <u>Utilities.</u> USER agrees that OLYMPIA shall pay the cost of all utilities, except telephone service. The cost of purchasing or leasing telephones and/or installing and maintaining same shall be the responsibility of the USER.
- 6. <u>Maintenance and Repair.</u> OLYMPIA shall provide janitorial services, to include vacuuming, emptying of garbage, washing of windows, dusting, and general cleaning on a schedule to be determined by OLYMPIA. OLYMPIA shall also provide maintenance services to include replacement of light bulbs, painting, interior repair, and toilet articles. USER is responsible for all repairs necessary due to the negligence of the USER, his/her agents, invitees or employees.
- 7. <u>USER's Repairs and Alterations.</u> USER agrees to keep the leased premises clean and in a sanitary condition, to repair and/or pay to repair any and all damage to the leased premises caused by the USER, and upon surrendering possession, to leave the leased premises in good condition, except for ordinary wear and tear. The USER will not make any alterations, additions, or improvements without prior written consent of OLYMPIA. The USER will not commit any waste or damage of the premises.
- 8. <u>Damage by Casualty.</u> In the event said premises shall be destroyed or damaged by fire or other casualties so that the same shall be unfit for use or occupancy, then OLYMPIA shall, within fifteen (15) days after said casualty, notify the USER whether or not OLYMPIA elects to rebuild the premise and lease it in the same manner. If OLYMPIA elects not to rebuild the premises, then this lease shall be terminated and all rents will be adjusted as of said date of OLYMPIA's decision. If OLYMPIA elects to rebuild the premises, then the rent shall be suspended for such period as USER is not in possession and until the premises can be made fit for the USER's occupancy. OLYMPIA and USER hereby expressly waive their right of



- subrogation against the other party and waive their entire claim of recovery against the other party for loss, damage, or injury from fire or other casualty, included in the extended coverage insurance endorsement, whether due to negligence of any of the parties, their agents, or employees or otherwise.
- 9. <u>Insurance</u>. The USER shall provide a certificate of insurance, including endorsements, showing evidence of commercial general liability insurance with combined single limits of liability not less than \$2,000,000 for bodily injury, including personal injury or death, products liability and property damage.
  - OLYMPIA must be named as an additional insured as respects this lease and such insurance as is carried by the USER is primary over any insurance carried by OLYMPIA. In the event of non-renewal, cancellation, or material change in the coverage provided, thirty (30) days written notice will be furnished OLYMPIA prior to the date of non-renewal, cancellation or change, such notice to be sent to the City of Olympia Associate Director/Recreation, 222 Columbia St NW, Olympia, Washington 98501. OLYMPIA has no obligation to report occurrences unless a claim is filed with OLYMPIA and OLYMPIA has no obligation to pay premiums.
- 10. Hold Harmless and Indemnity. The USER agrees to defend, indemnify, and hold harmless OLYMPIA, its appointed and elected officers and employees, from any and all claims, demands, losses, actions and liabilities (including costs and all attorney fees) to or by any and all persons or entities, including, without limitation, their respective agents, licensees, or representatives, arising from, resulting from, or connected with this Agreement to the extent caused by the negligent acts, errors or omissions of the USER, its employees, volunteers, or agents, or by the User's breach of this Agreement, except for such injury or damage as shall have been occasioned by the sole negligence of OLYMPIA, its appointed or elected officials or employees.
- 11. <u>Publicity</u>. USER agrees to provide OLYMPIA, specifically the CENTER Manager, with any and all publicity information affecting the CENTER.
- 12. <u>Termination</u>. This lease may be terminated in its entirety, or a portion of occupied space may be terminated, at any time by either party by thirty (30) days notice to the other party of such termination.
- 13. <u>Assignment and Subletting.</u> USER shall not assign this lease nor sublet the leased premises without the consent of OLYMPIA. USER agrees to pay all rent, maintenance and repair costs and all other expenses and costs contained herein. The collection of any and all assigned or sublet costs as agreed to between parties will be the sole responsibility of USER.
- 14. <u>Furniture</u>. USER shall provide, at its own expense, all furniture necessary for its possession and use in the leased office area of the CENTER. Furthermore, USER shall be responsible to



reasonably maintain said furniture and replace same, if necessary, to maintain decorum consistent with that of the remainder of the CENTER.

- 15. <u>Rules.</u> USER shall comply with all laws, statutes, rules, regulations, ordinances, and resolutions promulgated either by the federal government, State of Washington, or the City of Olympia. Such rules include any and all rules of operation and procedure issued by OLYMPIA.
- 16. <u>Hours and Days of Operation.</u> USER shall be entitled to use and possession of the facilities during normal hours in which the CENTER is open to the public. To maintain a safe and secure facility for staff and assets, OLYMPIA may close the CENTER under the following conditions and in this order:
  - 1. After 5:00pm on regular business days, or any time on Saturdays.
  - 2. Whenever no building rentals, recreation programs, or senior programs are scheduled.

The Senior Lobby and Health & Hygiene Room use are not considered as "programming" after 5pm on weekdays or on Saturdays. Accommodations for the Senior Lobby and Health and Hygiene may be considered on a case by case basis at the request of USER, and allowed at the discretion of OLYMPIA. Meeting or programming use of the Senior Lobby and Health and Hygiene Room by USER after 5pm on weekdays and all day Saturday will be scheduled with OLYMPIA through the established procedures for room use scheduling.

- 17. <u>Default.</u> It is agreed that if USER shall abandon or vacate said premises before the end of the term, or if any rent shall be due and unpaid, or if default is made of any of the covenants and agreements to be performed by USER as set forth herein, then OLYMPIA may, at its option, enter upon said premises and re-let the same for such rent and upon such terms as OLYMPIA may see fit, and if the full rental herein shall not be realized by OLYMPIA over and above any expenses to OLYMPIA to such re-letting, USER will pay all deficiency promptly upon demand, or OLYMPIA may declare said lease terminated and forfeited and take possession of the said premises. USER agrees to pay reasonable attorney's fees and court costs should it be necessary to enforce any of OLYMPIA's remedies in this paragraph.
- 18. <u>Audits.</u> Upon request, USER shall make all financial information, including revenues and expenses, available to OLYMPIA. Financial reserves shall likewise be made available. Any terms, conditions, or restrictions attached to operating or reserve funds shall be identified. Information must be itemized to show the revenues, expenses, and cash reserves of each component program of USER.
- 19. <u>Equipment Failure</u>. OLYMPIA shall not be responsible for financial and/or material loss of perishable food products as a result of mechanical or electrical failure or loss of any effects resulting from equipment failure.



- 20. <u>Security of Premises.</u> USER is responsible for securing all non-public areas under its lease upon completion of use. OLYMPIA shall not be responsible for any loss sustained by USER as a result of failure to properly secure facilities. Additionally, USER will indemnify, defend and hold OLYMPIA harmless from any liabilities, claims, suits or damages for any and all loss sustained by OLYMPIA arising out of USER's failure to secure and protect the leased premises.
- 21. <u>Notices.</u> All notices required or given under this agreement shall be given to the following persons:

#### **Background and Analysis:**

The purpose of OMC Chapter 3.16, Contracts, is to establish a uniform practice to approve and execute City of Olympia contracts, ensure Council review of important documents in an efficient manner and establish authority to execute these documents. This Chapter also requires that all documents related to real property be presented to Council before they are executed, with two exceptions in OMC 3.16.020.B:

(1) Dedication by a private developer to satisfy a permit requirement, and

## (2) Temporary construction licenses.

On December 10, 2015, staff made a presentation to the Land Use and Environment Committee recommending a third exception be added to OMC 3.16.020.B to address parcels needed to construct a project that has been previously approved by the City Council through the annual adopted Capital Facilities Plan.

## Neighborhood/Community Interests (if known):

A revised process will allow City staff to complete the acquisition process in a more efficient and timely manner:

- Allowing staff to engage Council early in the process concerning the need for right-of -way acquisitions, rather than after an offer has been made;
- Allowing staff to compensate the property owner when the agreement is reached;
- Allowing the project to move to construction sooner;
- Avoiding the necessity of bringing every right-of-way parcel acquisition back to Council for approval before execution of the purchase agreement by the City Manager.

## **Options:**

Approve the proposed changes to OMC Subsection 3.16.020. Staff will be able to complete property acquisitions in a transparent, efficient manner.

Do not approve the proposed changes to OMC Subsection 3.16.020.B. Staff will continue our current practice of bringing each property acquisition to Council for approval after negotiations with the property owner is complete. No efficiency will be realized.

## **Financial Impact:**

The proposed process will reduce project costs by eliminating the need to draft, review and finalize multiple staff reports. The actual amount varies depending on number of parcels acquired in connection with the Council approved project.

AN ORDINANCE OF THE CITY OF OLYMPIA, WASHINGTON, RELATING TO COUNCIL APPROVAL OF CERTAIN DOCUMENTS, AMENDING SECTION 3.16.020 OF THE OLYMPIA MUNICIPAL CODE.

**WHEREAS**, Olympia Municipal Code 3.16.020 currently requires that City Council approve each instrument pertaining to the City's use, disposition, conveyance, or acquisition of real property even for projects that Council has already approved through its capital improvement project process; and

**WHEREAS**, the process tends to frustrate progress, in particular, on projects where the City must acquire multiple right of way parcels; and

**WHEREAS**, adding a third exception to section B of Olympia Municipal Code 3.16.020 will allow for a more efficient process by authorizing the City Manager to sign certain instruments when associated with a capital improvement project that has previously been approved by City Council;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL ORDAINS AS FOLLOWS:

Section 1. <u>Amendment of OMC 3.16.020</u>. Olympia Municipal Code 3.16.020 is hereby amended to read as follows:

#### 3.16.020 Council Approval

The following documents and instruments shall be presented to the City Council for approval prior to their execution by the City Manager:

- A. Interlocal agreements: All contracts, agreements, memoranda of understanding, or other documents between the City of Olympia and any other governmental agency or agencies. An agreement in association with a grant application is not considered an interlocal agreement for purpose of this subsection but is subject to the monetary thresholds in Subsection C.
- B. Instruments pertaining to real property: any contract, agreement, lease, easement, bill of sale, or other instrument pertaining to the City's use, disposition, conveyance, or acquisition of real property.

#### Exceptions:

- (1) An acceptance by the City in its regulatory capacity of a dedication from a development is not subject to this subsection Council approval.
- (2) Temporary construction licenses are not subject to this subsection Council approval.
- (3) The City Manager is authorized to sign the following without further City Council approval:

  All instruments pertaining to the City's use, disposition, conveyance, or acquisition of real property

by whatever method, provided that such transaction is associated with a capital improvement project that has been previously approved by Council.

C. Any contract, agreement, or other document with a cost over \$300,000.

**Section 2. Severability.** If any provision of this Ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or application of the provisions to other persons or circumstances shall remain unaffected.

**Section 3.** Ratification. Any act consistent with the authority and prior to the effective date of this Ordinance is hereby ratified and affirmed.

**Section 4.** Effective Date. This Ordinance shall take effect five (5) days after publication, as provided by law.

With support from the Utility Advisory Committee, staff completed an in-depth evaluation of aquatic habitat within the City. This evaluation identified and prioritized habitat needs, and recommended various approaches for protecting and improving habitat. Staff presented the resultant Habitat and Stewardship Strategy to the Utility Advisory Committee in January 2014 and to the City Council in May of 2014.

Subsequently, staff launched a two-year pilot project to implement portions of the strategy. This included habitat planning on both public and private lands, implementation of a variety of restoration projects, and the creation of multiple partnerships. Partners include other City Departments/work groups, other agencies, neighborhoods, and private property owners.

Staff will provide the City Council with a progress report on the first year of this work effort.

## **Program Development Overview**

The Storm and Surface Water Utility has three primary goals: minimizing flooding, maintaining or improving water quality, and protecting and enhancing aquatic habitat. The habitat program was created to implement the 2013 Habitat and Stewardship Strategy by focusing additional resources on aquatic habitat protection and enhancement City- wide. Work was initiated in October 2014 when new staff was hired and existing staff dedicated a portion of their time on habitat stewardship efforts. The program supports City-wide environmental enhancement priorities and projects.

**Program Goal:** Partner with the community to protect, steward, and restore aquatic, riparian, and associated terrestrial habitats within Olympia's watersheds.

## **Program Objectives:**

- 1. Restore and facilitate natural processes in aquatic and associated habitats within the City of Olympia.
- 2. Restore and enhance upland forest, riparian forest, and wetland native species and structural diversity.
- 3. Preserve and restore riparian habitats to support a diversity of native wildlife and plant species.
- 4. Support neighborhood advocacy and stewardship of aquatic and associated habitats.
- 5. Improve water quality and aquatic habitat of streams, lakes, Budd Inlet, and adjacent shoreline.
